Comments for Public Posting: Hello, my name is Phyllis Ling. I'm a resident and property owner in the Chinatown area. I am opposed to the establishment of the Chinatown BID. Yesterday, on Tuesday September 29, at the public hearing for the Chinatown BID Establishment, there were significant obstacles that severely curtailed the public's ability to provide public comment: 1. the Notice of Public Hearing to Establish the Chinatown BID (attached) provided an incorrect meeting ID . I called shortly after 10am using the instructions on the notice. Zoom said this meeting does not exist. I had to go online for instructions from the general City Council agenda. Considering that the Chinatown BID area includes many benevolent associations, and older residents and business owners who do not have internet access, the incorrect information on the BID hearing notice likely prevented many from joining the meeting to provide public comment. 2. For those who were able to join the meeting, there was another obstacle. Early in the meeting. City Council announced that the interpreter for this meeting was running late, and that comments for this agenda item would be allowed later in the meeting as well. However, after the first round of public comments was closed, I was disconnected from the call, as were other callers. I called back into the meeting twice, and got the message that the meeting had not started. All I heard was elevator music, not what was being discussed in City Council chambers, so I hung up both times. The only reason I knew when to call in again for public comment was because I was able to go online and watch the meeting from the website. I made an abbreviated version of these 2 comments yesterday at the meeting, which ate up a lot of my 1 minute public comment opportunity. I was able to make a couple of comments in opposition to the certification of the ballot results and establishment of the Chinatown BID, that I would like to elaborate on here: The City Council has already bent over backwards to establish this BID. The BID missed the normal deadline for renewal, didn't have anywhere close to the petitions that they needed, and you approved special funding for a renewal consultant. In an unusual move, the City Clerk's office is being instructed to direct bill the property owners, rather than going through the property tax rolls. This process is corrupt. And all this is being done so that The Los Angeles Chinatown Business

Council, the non-profit that has been running the BID, can continue its operations uninterrupted. So that they can continue to violate the Brown Act and CPRA. So they can continue to force people to attend their board meetings in person to make public comment and/or not provide any instructions on their agenda for how the public can attend virtually. So that they can continue to harass the unhoused in our communities. So that they can provide services outside of their boundaries, a clear violation of their authority. So that they can operate in secret to help their friends and help developers. The City should not approve a contract with this non-profit to manage tax-payer funds. Taxpayers should not be forced to subsidize this unaccountable organization. Sincerely, Phyllis Ling
