- Distance from Sensitive Areas
- "Opt Out" feature for allergic people and children


I believe the signatures attached reflects the true sentiment shown in the Community when given a chance to discuss the issues. These were greatly concerned of the lack of serious safety shown in the current Ordinance. Some were reluctant to sign until they studied it out. Some did not want to sign because they did not want to get involved. One person changed his mind and crossed out his signature saying he didn't want more politics. We welcomed and appreciated all comments.

These 215 signatures were obtained in the MarVista and Venice areas in less than 5 hrs. Please find a sample of the photos taken that day of those supporting the additional change needed.

On the other hand, Please find the first and last page of the Ordinance proponent, Honey Love, spanning over 3 years, yet submitting only 193 Los Angeles claimed signatures (see breakdown).

We ask you again, to please VETO the proposed Ordinance and send it back to City Council to make the necessary changes. If you have signed it already, please do not forward it to the clerk for publishing. If the City Clerk has it, please ask to not have it published.
