Your **PERSONNEL AND ANIMAL WELFARE COMMITTEE**

reports as follows:

PERSONNEL AND ANIMAL WELFARE COMMITTEE REPORT and ORDINANCE relative to amending Ordinance No. 182202 (2012-13 and 2013-14 Fiscal Year Salaries and Benefits) to reflect updated biweekly salaries of nine General Manager positions effective January 1, 2013 and July 1, 2013.

Recommendations for Council action, SUBJECT TO THE APPROVAL OF THE MAYOR:

1. PRESENT and ADOPT the accompanying ordinance to amend Ordinance No. 182202 (2012-13 and 2013-14 Fiscal Year Salaries and Benefits) to reflect updated biweekly salaries of nine General Manager positions effective January 1, 2013 and July 1, 2013.
2. AUTHORIZE the Controller and the City Administrative Officer (CAO) to correct any clerical errors or, if approved by the City Attorney, any technical errors in the ordinance described above in Recommendation No. 1 and in the May 2, 2013 City Attorney report, as attached to the Council file.

Fiscal Impact Statement: The CAO reports that no appropriation of funds is required as an increase in costs will be absorbed within existing budgeted funds for the affected departments or bureaus.

Community Impact Statement: None submitted.

Summary:

On June 4, 2013, you Committee considered May 9, 2013 CAO and May 2, 2013 City Attorney reports relative to amending Ordinance No. 182202 (2012-13 and 2013-14 Fiscal Year Salaries and Benefits) to reflect updated biweekly salaries of nine General Manager positions effective January 1, 2013 and July 1, 2013. According to the CAO, the proposed ordinance is intended to amend Ordinance No. 182202 (Non-represented salaries and benefits for Fiscal Years 2012-13 and 2013-14) to reflect updated salaries of nine General Manager positions. This technical correction is necessary to provide for revised biweekly salary rates effective January 1, 2013 and July 1, 2013, following salary adjustments authorized by the Mayor subsequent to the adoption of the original Non-represented Ordinance by the City Council on August 1, 2012 (Council File No. 12-1148).

After consideration and having provided an opportunity for public comment, the Committee recommended approval of the recommendations contained in the May 9, 2013 CAO report and detailed in the above recommendations.

This matter is now submitted to Council for its consideration.
