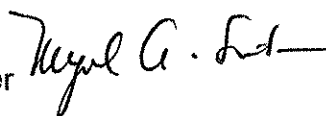

Subject: **NON-REPRESENTED ORDINANCE NO. 182202 - TECHNICAL CORRECTION
UPDATED GENERAL MANAGER SALARIES**

Submitted herewith is a proposed ordinance, approved as to form and legality by the City Attorney, to amend Ordinance No. 182202 (Non-represented salaries and benefits for Fiscal Years 2012-13 and 2013-14) to reflect updated salaries of nine General Manager positions. This technical correction is necessary to provide for revised biweekly salary rates effective January 1, 2013 and July 1, 2013, following salary adjustments authorized by the Mayor subsequent to the adoption of the original Non-represented Ordinance by the City Council on August 1, 2012 (C.F. 12-1148).

Recommendations

1. That the City Council, subject to the approval of the Mayor, adopt the attached Ordinance approved as to form and legality by the City Attorney to amend Ordinance No. 182202 to provide for revised biweekly salary rates effective January 1, 2013 and July 1, 2013 for nine General Manager positions; and
2. That the City Council authorize the Controller and the City Administrative Officer to correct any clerical errors or, if approved by the City Attorney, any technical errors in the above Ordinance.

Fiscal Impact Statement

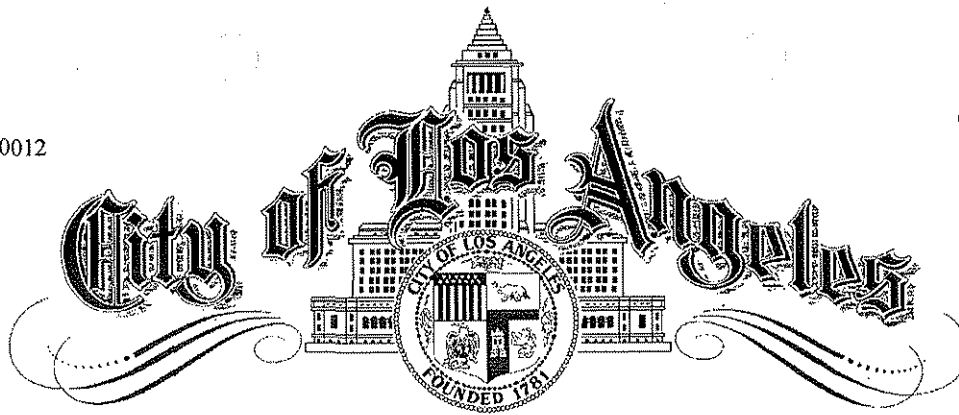
No appropriation of funds is required as any increase in costs will be absorbed within existing budgeted funds for the affected departments or bureaus.

Council Rule 38 Referral

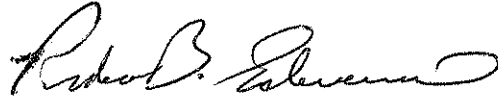
Pursuant to Council Rule 38, the ordinance was referred to the City Administrative Officer (CAO). The CAO recommends adoption of this ordinance.
