The City Council ADOPTED the following recommendation(s) relative to levying the Wilshire Center Business Improvement District ("District") special assessment for the District's twentieth fiscal year (operating year) beginning on January 1, 2015 through December 31, 2015, SUBJECT TO THE APPROVAL OF THE MAYOR:

- 1. HEAR PROTESTS against the proposed levying of the special assessment for the District's 2015 fiscal year, pursuant to Section 36524 of the California Streets and Highways Code.
