Brief Summary: On 01/07/14, the Eagle Rock Neighborhood Council voted (10 in favor, 1 against, 2 abstentions) to support the Motion to instruct the Police Department and City Attorney, with the assistance of the Chief Legislative Analyst and City Clerk, to report with recommendations to establish a standing reward offer for hit-and-run crimes that occur in the City of Los Angeles.

Additional Information: As Eagle Rock, and greater Los Angeles, become more aware of residents who walk, bike, and take public transport, the City must do all it can to ensure that these citizens are treated equally under the law. Providing rewards for the arrest and prosecution of hit and run drivers is one step toward that recognition.

6 – tree planting, concrete cuts, do we measure it off or give you the block locations. A – more specificity is better.

7 – priorities are tree stump locations and what else? A – no clear answer yet but we will notify in advance.

7 – we have over 100 locations identified.

4 – bike lanes on Colorado Blvd has not slowed traffic, could timing of lights play part in slowing down traffic, why hasn't it been slowed down? A – our goal is to get this under control, we realize the problem but that is not finished yet.

6 – speed feedback signs when? A – Feb I think.

III. New Business:

- a. Update : answered by Nate. Jan.
- b. Update: Land Use Committee Mr. Greene: Nothing official to vote on, got information on one new business on Colorado Blvd. by Brownstone.
- c. Update: Public Safety Director: Ms. Deutsch. Nothing to report.
  - 5 – there was a business broken into that was supposed to have a photo released. A- will check into it.
- d. Utility Box Update: Mr. Goldfarb, 17 boxes eligible for painting. 14 on CO Blvd, 3 on Eagle Rock Blvd. There are design criteria and design must be approved by council. Sponsoring organization must sign on to take care of each one. Suggestion is a committee to solicit design proposals and would chose the best choices. Boxes sanded, primed and painted with special paint to make graffiti removal easier. Artist stipend is suggested also. Funding must be in place. Center for arts is a 501©(3) so donations could go to them.
  - 7 – I would not recommend the ERNC spearhead this so handing it over to a local group would be the best choice.We will get back in touch and continue to update.
- e. Update Banner committee: Mr. Greene. We decided on design a while ago, and it is ready to go if we want it. \$2500 deposited with the banner company. Up to \$7500 has been committed. Banners are about \$145 each. We will put it online for people to review.
- f. Recommendation to approve Treasures Report: Ms. Atkinson. We only need the December expenditure and Jan planed. Three grant applications received 4,980, 4,709 available. We met in November and got clarifications. Applicants are here to present requests. We may reallocate Neighborhood purpose grants depending on money available. There are also items on agenda for community improvement projects. 12250 allocated for community improvements, 935 expended so far. Three proposals tonight, trash cans, event, and tree planting represents more money than what we have after the banner project.
  - 1- Banner money already spent right? A- deposit yes, allocated no.
  - 6 –with my math we have about 3800 left if we spend money on banners? A-yes.
  - 6 - about 4700 for neighborhood purpose grants.? A –yes.
  - 8 – are we giving public notice on grants? A – yes on our website.  
  - 6 – moves to approve December expenditure and Jan treasurers report. 8 seconds.Unanimous vote.

III. g. Community improvement process. Public trash cans. Mr. Greene.  
We talked about this before. There are 4 now on CO. Blvd. replacing white wire. Trash trucks come and pick them up. If we replace the 24 existing white cans around ER, would need to be done before we pick new locations. Sanitation has offered to split 50/50 with the CD-14. ER proposing to do a 25/25 split with CD-14. 25% equates to 80

per can. May be as high as \$106 per can if 3 way split. Our Logo has to go on the can, City seal, and CD-14 logo. \$400 set up, labels \$400 extra on top of the cans. We have to buy at least 24 before we can decide what additional cans. Determination is we need 48 cans.

0 – which bucket? A – community improvement project bucket.

2 – any difference for recycling? A – different color, blue instead of Green.

We have to make a pitch to CD-14 first step before it would go to Sanitation.

8 – we need to do this now? A- yes while they are thinking about this.

7 – recycling again, how does that fit into the proposed cans? A – 48 is trash only, but the additional cans could be either.

10- we would need to unfund banners to have enough money to do this.

6 - Suggestion to table this until after we see what we have.

10- we still should vote on the banners first.

6 – yes but motion could be made to use the rest of available money.

7- we could reconfigure the money.

6 - changing funding for banners is not on agenda. The garbage cans issue is. We need to make our decision on the cans.

7 – I would want to hear the other proposals on this funding topic.

6 – moves to table, 7 seconds. Unanimous vote.

III. h. street cutting and planting. 7 – subdistrict directors surveying their subdistricts for viable locations underway. We have about 100 identified so far. Other organizations may also be identifying locations. We want a preliminary list of concrete cuts, dead trees and stumps and locations by January 15<sup>th</sup>.

1- Is there a certain width? A – 6 feet from edge of tree well.

7- narrow residential sidewalks will not be viable locations.

12 – what about watering. A - maintaining requires sponsors. We might find an organization to do this.

6 – feeling I get from CD-14 is conservation corps might offer a deal for a group of trees. There are stretches on CO blvd for example with no trees because no one wanted to take responsibility.

12- worried about drought and increased cost of water which would impact this how? 7 – tree saves more water than it uses.

1 – I suggest we hire somebody to make sure this happens, it is very important to ER. There are probably over a 1000 possible locations.

7 – biggest impediment to this project is people taking care of the trees.

5 – history, trees have been planted before and biggest issue is upkeep. 2-5 years later they need to be maintained and haven't been historically.

7 – not necessarily holds true that people won't do this.

2- Motion to spend up to 1200 to contract work over next two weeks. Motion withdrawn.

Public comment: Jack Goldhammer, I would like to know who is getting cans that are being thrown away. A – city takes them back, they belong to the city.

Way too low on the cans, there should be two per block. White cans should be used to fill in other areas where there are needed.

6 - problem is cans don't empty themselves, so they are being replaced.

III. i. Discussion/Action: Ms. Anderson. Faith based leaders have met and planned an event at 7 locations in the area. People will pray for members of various groups in the city. We would like funding support with credit to ERNC for their support.

5 – this has nothing to do with peace walk correct? A - no it does not. That is a march down ER Blvd in March.

6 – can you tell us more? A. FB people are going to invite the public.

6 - ERNC needs more specifics. A – all the churches in ER.

2 – what religions are represented. A – trying to find out.

6 – can you please give us more specifics about who is involved. This is our standard practice.

A – FB director of this board. I brought people together.

6 – we don't sponsor secret projects. A – ER Pres., Christian assembly, there are about 15. St. donovans. I can forward the list.

6 – what will occur on this date, what will the flyer say? A – that the community is invited to come and pray for our community. Multiple locations. City hall, schools, we will have candles and incense. FB leaders will go to the 7 locations between 7 and 8:30. They will move between locations.,

8 –well there be specific context. A – we will leave it up to the ministers.

11- it sounds like a lovely event , but concerned about sponsoring a religious event.

12 – what do you envision that a FB director should do.

11 – event sounds wonderful.

0 – government can't endorse religion.

6 – most of us do things that do not involve money, we engage the community. What you are doing is exactly what we envisioned.

7 – I would feel uncomfortable with the ERNC supporting something where we did not know specifically what content we were supporting.

5 – all we can do is put it up for a vote.

12 - moves that ERNC pay for printing for this event. No second. Motion fails.

5 – we appreciate what you are doing, to engage the community.

0 – there is a distinction between religious organizations doing public work vs. doing religious work.

3. g. again. Mr. Greene. 10 – 3780 to spend as of this moment, unless we take money away from something else or get back our 9600.

6 – you cant alter the banner money at this meeting so we must work with what we have left in this meeting.

10- we can change later but right now that is all we have to work with.

6 – so if we use all the NPG money this time then we can free up other funding next time.

0 – was banner up to 7500? A – yes.

6 – 3780 left, which is approx 42 trashcans. I move we spend up to 3780 for new trash cans in the form of a proposal to split cost with CD-14.

3 – we don't know CD-14 will accept right? A – right. But it is a real possibility. It would take a council motion to get the money. We need to commit first.

2 seconds motion.

9- any idea when CD-14 would move forward. A – soon, we can always repurpose the money if they don't.

Vote: 10 opposed. 12 abstained. Motion passed.

III. j. 10 –

5 – did ERHS ask alumni for money. A – not sure.

10 – our recommendations total 3720.

ERHS – no one present. Their request for 4000 to restore eagle mural on side of auditorium. They have an artists proposal for 4000, we asked if the ERNC funded a portion would they get the rest somewhere else. They said yes, Finance committee could now come to agreement so no recommendation.

10 – two wanted to recommend 1,000.

6- two didn't think it was the kind of thing ERNC should support.

10- fee seems reasonable. New mural is in packet.

5 – ERHS has other funding sources.

9 – they should have been here if it was important to them.

11- are we going through each proposal then vote.

2 –yes we can wait for motion.

ER Elementary: Amanda Millett full request 4650, recommendation 2320. Would like to bring shared public spaces greening, more park space. Trees on north parking lot, LAUSD would maintain trees if we add them. We would look at improving runoff.

7 – I wonder about the public accessibility. Does it serve just the students? A – currently space is a public park, walkway, throughway, no intention of gating. We would like to gate it eventually.

11- the plans you sent have a fence indicated. A-yes.

11 – can you explain the grant you received. A- in 2010 a group of parents received a storm water mitigation grant, we got 350,000 to green our school grounds. When we originally drew

the plans we wanted to also green this extra property, but we cant use that grant based on wording in the grant.

4-who uses the parking lot right now? A – staff and teachers.

6 – you sent a supplemental letter because you did not mention the grant and you submitted the master green plan, you said the west lawn gate plan would not be funded by the state grant. So this is public land, but your plan would gate this off? A – on the west lawn by the auditorium, it would be gated but open during school days, but no agreement yet on how the gate would work.

7 – I feel we would need to know that before we could allocate funding. A –the area we are asking for ERNC to fund is outside the gate. We are asking for 5 trees and native plants funding from ERNC.

6 – completion date is one year out. Would this money go to this discreet project or would this go into a pool? A –this would be a separate project. This can be done immediately, as soon as March.

7 – irrigation? A – not in tree wells but we found a solution.

2996 to refurbish pots and other landscaping Cheryl Weaver. CERB. We would be grateful for any funding. 10 pots are part of a bigger project. 44 pots deteriorated and falling apart, but these 10 are the worst and not holding water or plants anymore. We are going to other organizations for the other pots. We are only supported by the community. 180 per pot but guaranteed that these wont be destroyed by the sun. also bigger pots than current. We have plenty of volunteer resources to do the work. Total project is 10800, we are only asking for 2996.

4- not terracotta? A- no, plastic.

11 – warranty? A –yes.

7- do you have a picture. A- yes, and one on street avenue 45 and Eagle Rock are replaced.

7- how long in place and are you happy with them. A – 1 year, and yes.

5 – problem is cars jump curb and hit the pots. These are wonderful pots being maintained but need new pots.

6 – whats the history on permanent planting? A – city has to cut up the asphalt, but we try to do that whenever possible. But we have no funding to do this work.

1-You did the trail by ER which is beautifully maintained.

6 – so It would be better to have them permanently installed? A- yes and if we can we will.

6 – how did it occur the first time? A – it was open space and concrete was going to be poured so we were able to do it.

5 – there was another pilot program at the ER plaza where the curbing was stained to make it more appealing.

Jack – I talked to Nate and asked if the city would hook up the pipes they shut off it would be great.

ER Community Garden 3334 to build raised beds. Recommendation is 500 for a portion of the beds.

Mike Woodward – manager of ER community garden. We have 40 plots currently. Volunteer run, we have tried many ways of having raised beds. We believe that a tracks like material. 2x6 doubled up should last about 20 years. Money is for materials only, labor provided by the Garden members. 3300 would build 20 beds, we built 10 which costs 1600.

5 – who uses the community garden? A – members of ER can sign up to use it.

10 we had a question in committee about how people can find about availability? A – we have put out flyers, had open house, we do have turn over during the year. We bring people in at the beginning of summer or winter planting. WE would like to expand at some point but have 40 beds now.

7 – is there signage on the gate with contact info? A – no. We are talking about how to do that.

10- that was one concern, we think it is a valuable asset just wish more people had a way to contact someone. A – we agree.

Discussion or motion:

1 ERJR High motion no money, 6 seconds. One abstained 11. Mptino passes.

ER Elementary: 6-makes alternate proposal, items 2,3,4 are all worthy projects we should fund for 1000 each.

1 moves to give ER Elementary Education Foundation, 8 seconds. Discussion, Mr. Ramierz makes friendly amendment for fund for 1000, 1 accepts that amendment, 3 seconds friendly amendment.

Discussion: 7 – 1000 doesn't go far enough in my opinion. It's a real stretch. A – I cant tell you right now how far that would go.

Mr. Ramierez. Why not split the 4075 evenly between the tree. 1578 each.

1 withdraws motion.

Mr. Ramierez moves to split evenly equal to 1578.33 each. 7 seconds.

Discussion: 5 –garden needs to do more outreach to people.

Need to vote on each one.

Mr. Ramierez moves ER Elementary Education Foundation 1575 Ms. Frier seonds. Unanimous vote.

Mr. Ramirez votes 1575 to , 7 seconds 12 abstains.

Mr. Ramirez moves 1575 to ER commjnty garden . 7 seconds. Unanimously approved.

Tribal secretary and tribal biologist present as well. Original peoples of LA and Orange Counties. Tribal goal is to restore culture and educate public. Published first tribal book, Toypurina The Joan of Arc of California. First monument in ER then we would like to see others around the county. The tribal names for Eagle Rock will be part of the monument. The proposed monument is based upon ancient monuments erected on sacred sites. (Artist conception provided). Five stylized baskets that go up a pole with specific meaning to the baskets. 5 baskets represent the 5 worlds of the tribe. One basket at top is inverted with a tribal related logo. This would be made out of bronze, artist is donating time. Not asking for money, but would like your support. It will be secure and hard to vandalize. 9 feet high.

There will be a native plant garden around the monument. Maybe have ER scouts help plant the garden. We can provide signage and website about the plants. Very educational garden. We have lost touch with our heritage regarding our plants, and the public needs education.

This is a sacred site, at the Eagle Rock. Tooawt Totay is Eagle Rock in our native language.
