- A. **LAPD SENIOR LEAD OFFICER DAVE HAM-** Reported that crime is down in Lake Balboa area, His email is 25717@lapd.lacity.org, phone 818-731-2551. He left flyers were left with all Senior Lead names, phone numbers and emails to contact them; crime is down in all the West Valley; there was a shooting and a stabbing at a party in Reseda;

Lake Balboa is down except for cars being broken into around the Sepulveda Basin area, please Lock It, Hide It, Keep It; there is an issue with older cars being stolen for transportation in the Van Nuys area between the airport and 405 south of Roscoe to Victory. Suggest putting a club, a kill switch, an alarm or a locking device for the pedals; put locks on gates to prevent break-ins, make sure you lock up your home, don't leave valuables by the front window to be seen; make friends with your neighbors; put cameras outside on property; get a dog; start a Neighborhood Watch Group, if there is a problem call the neighborhood block captain, give the information, she will contact the Senior Lead.

- B. **LAPD Sergeant Gary Payton**- He introduced himself; encouraged talking to neighbors, hiding your valuables, call him with any questions.
