We represent the Long Beach Unified School District (District) in connection with the
above-referenced matter.

Pursuant to Public Resources Code § 21161.10, the District hereby requests that the Port of
Los Angeles and BNSF Railway Company participate in mediation regarding the decisions of the
Port of Los Angeles Board of Harbor Commissioners, as upheld by the Los Angeles City Council, to
certify the final environmental impact report for the Southern California International Gateway
(SCIG) project, and to approve that project. This request for mediation pertains to any and all
approvals for the SCIG project, including but not limited to the certification of the Final EIR, and
adoption of Findings of Fact, the Statement of Overriding Considerations, and Mitigation
Monitoring and Reporting Program by the Board.

Section 21167.10 of the Public Resources Code provides, in relevant part:

Within five business days of the filing of a notice required by...Section 21152 [requiring filing of Notice of Determination] by the lead agency, a person wishing to bring an action or proceeding... may file with the lead agency and the real party in interest a notice requesting mediation.

Within five days of the receipt of this notice, the City Council and/or Board of Harbor Commissions may respond by either accepting or denying the District's request for mediation. (Pub. Res. Code §§ 21167.10 (b)-(c).) If it is accepted, pursuant to the statute, the limitation period for filing a lawsuit will be tolled until the mediation is completed.
