PUBLIC SAFETY COMMITTEE REPORT relative to the donation of a commercial washer, dryer, and treadmill for use by Los Angeles Fire Department (LAFD) Fire Station 50 personnel.

Recommendation for Council action:

AUTHORIZE LAFD to accept the donation of a commercial washer, dryer, and treadmill (and equipment installation), with a total value of \$6,763.00, from NBC Universal, for use by LAFD Fire Station 50 personnel, and THANK the donor for this generous gift.

Fiscal Impact Statement: LAFD reports that there is no fiscal impact to the Department's budget in the acceptance of this donation. The members of Fire Station 50 shall be solely responsible to maintain, repair, and/or replace these donated items.

Community Impact Statement: None submitted.

#### SUMMARY
