COMMUNICATION FROM CHAIR AND MEMBER, PUBLIC SAFETY COMMITTEE and ORDINANCE FIRST CONSIDERATION relative to authorizing reward offers for information leading to the arrest and conviction of individuals who make false 911 swatting calls.

Recommendation for Council action, SUBJECT TO THE APPROVAL OF THE MAYOR:

PRESENT and ADOPT the accompanying ORDINANCE amending Section 19.123 of the Los Angeles Administrative Code (LAAC) to authorize reward offers for information leading to the arrest and conviction of individuals who make false 911 swatting calls.
