The City Council ADOPTED the following recommendation(s), contained in a COMMUNICATION FROM THE CITY ATTORNEY which was WAIVED, pursuant to Council Rule 17, by the Chair of the Personnel and Animal Welfare Committee, SUBJECT TO THE APPROVAL OF THE MAYOR:

PRESENT and ADOPT the accompanying ORDINANCE amending Chapters 10 and 11 of Division 4 of the Los Angeles Administrative Code (LAAC) to reorganize the provisions of Los Angeles City Employees Retirement System (LACERS) and to incorporate changes required to maintain the tax-qualified status of the Plan, and to make technical amendments to Chapters 18 and 18.5 of Division 4 of the LAAC related to the creation of a second tier for LACERS.
