The weighted value of the supporting ballots **exceeds** the weighted value of the opposing ballots.

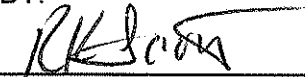
SECTION 2. Protests received, pursuant to Section 53753(d) of the California Government Code:

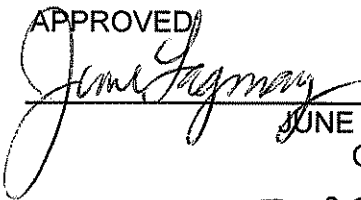
No speaker cards were received from the public.
