MITIGATED NEGATIVE DECLARATION and PLANNING AND LAND USE MANAGEMENT COMMITTEE REPORT relative to an appeal filed for property located at 11764 West Idaho Avenue.

Recommendations for Council action:

- 1. - 2. ADOPT the FINDINGS of the Planning and Land Use Management Committee as the Findings of the Council.
- RESOLVE TO DENY THE APPEAL filed by Reza Sarafzadeh (Representative: Sheri Bonstelle/Neill Brower, Jeffer Mangels Butler and Mitchell, LLP), from the entire determination of the West Los Angeles Area Planning Commission (WLAAPC), and THEREBY:
  - a. SUSTAIN the decision of the Deputy Advisory Agency and APPROVE Tentative Tract No. TT-71891-CN-1A, for a one lot subdivision for a maximum eight-unit residential condominium in the West Los Angeles Community Plan, for property located at 11764 West Idaho Avenue, subject to modified Conditions of Approval.
  - b. OVERTURN the Zoning Administrator's decision and DENY the reduction in open space for DIR-2012-3192-DD-1A, for a maximum eight-unit residential condominium in the West Los Angeles Community Plan, for property located at 11764 West Idaho Avenue.

## Summary

At a regular meeting held on September 17, 2013 (continued from September 10, 2013), the Planning and Land Use Management (PLUM) Committee considered an appeal filed for property located at 11764 West Idaho Avenue. Staff from the Department of City Planning gave the Committee background information on the matter. A Representative for the applicant/appellant as well as staff from the Council District 11 spoke. Council District 11 requested the PLUM Committee to approve revisions to the Findings.

After an opportunity for public comment, the Committee recommended that Council approve the revised Findings and deny the appeal filed by Reza Sarafzadeh from the entire determination of the WLAAPC, and thereby: 1) sustain the decision of the Deputy Advisory Agency and APPROVE Tentative Tract No. TT-71891-CN-1A, for a one lot subdivision for a maximum eight-unit residential condominium in the West Los Angeles Community Plan, for property located at 11764 West Idaho Avenue, subject to modified Conditions of Approval and 2) overturn the Zoning Administrator and deny the reduction in open space for DIR-2012-3192-DD-1A. This matter is now submitted to Council for its consideration.
