


ORDINANCE NO. 183808

Section \_\_\_\_ Section 12.04 of the Los Angeles municipal Code is hereby amended by changing the zone classifications of property shown upon a portion of the Zoning Map incorporated therein and made a part of Article 2, Chapter 1 of the LAMC, so that such portion of the Zoning Map shall conform to the zoning on the map attached hereto and incorporated herein by this reference.



## DECLARATION OF POSTING ORDINANCE


I, VERONICA COLEMAN-WARNER, state as follows: I am, and was at all times hereinafter mentioned, a resident of the State of California, over the age of eighteen years, and a Deputy City Clerk of the City of Los Angeles, California.

Ordinance No.183808 – Zone and Height District change for properties at 1600, 1604, 1606, 1608, 1610, 1612, 1614, 1616, 1616 1/2, 1618, and 1618 1/2 North Highland Avenue, 1600, 1606, 1612, 1616, and 1622 North McCadden Place; and 6709, 6757, 6757 1/2, 6759, 6759 1/2, 6761, 6763, 6765, 6767, 6773, 6775, and 6777 West Selma Avenue – CPC-2015-1556-ZC-HD - a copy of which is hereto attached, was finally adopted by the Los Angeles City Council on August 4, 2015, and under the direction of said City Council and the City Clerk, pursuant to Section 251 of the Charter of the City of Los Angeles and Ordinance No. 172959, on August 12, 2015 I posted a true copy of said ordinance at each of the three public places located in the City of Los Angeles, California, as follows: 1) one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall; 2) one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall East; 3) one copy on the bulletin board located at the Temple Street entrance to the Los Angeles County Hall of Records.
