Ordinance No. 187205
An ordinance amending Section 46.04 of the Los Angeles Municipal Code to establish a new fee schedule for applications for permits to remove or relocate a protected tree or shrub.

THE PEOPLE OF THE CITY OF LOS ANGELES

DO ORDAIN AS FOLLOWS:

Section 1. Section 46.04 of the Los Angeles Municipal Code is amended to read as follows:

SEC. 46.04. FEES.

An application for a permit to remove or relocate a protected tree or shrub under this article shall include the following fees:
(a) Permit Application Fee. A nonrefundable permit application fee of \$805.99; and

(b) Inspection Fee. A nonrefundable inspection fee in the following amounts:

- 1. Permit application for one or two protected trees or shrubs: \$2,892.48.
2. Permit application for three to five protected trees or shrubs: \$5,139.16.
3. Permit application for six to ten protected trees or shrubs: \$5,982.58.
4. Permit application for more than ten protected trees or shrubs: \$5,982.58, with an additional fee of \$1,070.76 for each set of up to five additional protected trees or shrubs above ten.

Sec. 2. The City Clerk shall certify to the passage of this ordinance and have it published in accordance with Council policy, either in a daily newspaper circulated in the City of Los Angeles or by posting for ten days in three public places in the City of Los Angeles: one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall, one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall East, and one copy on the bulletin board located at the Temple Street entrance to the Los Angeles County Hall of Records.
