An ordinance amending Section 4.245.1 of the Los Angeles Administrative Code, pertaining to vacation hours for non-represented executive and managerial positions, to add the positions of Executive Director Office of Public Accountability and Assistant Airport Police Chief.

**THE PEOPLE OF THE CITY OF LOS ANGELES
DO ORDAIN AS FOLLOWS:**

Section 1. Subsection (a) of Section 4.245.1 of the Los Angeles Administrative Code is amended to add the following classification effective February 14, 2012:

<u>Class Code</u>	<u>Class Title</u>
0748	Executive Director Office of Public Accountability

Sec. 2. Subsection (a) of Section 4.245.1 of the Los Angeles Administrative Code is amended to add the following classification effective upon adoption of this Ordinance:

<u>Class Code</u>	<u>Class Title</u>
3234	Assistant Airport Police Chief

Sec. 3. This ordinance shall be operative upon publication pursuant to Charter Section 252(g).

Sec. 4. The City Clerk shall certify to the passage of this ordinance and have it published in accordance with Council policy, either in a daily newspaper circulated in the City of Los Angeles or by posting for ten days in three public places in the City of Los Angeles: one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall; one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall East; and one copy on the bulletin board located at the Temple Street entrance to the Los Angeles County Hall of Records.
