An ordinance amending Note 1 of Salary Notes applicable to the Recreation and Parks Department in Section 4.61 of the Los Angeles Administrative Code, pertaining to the residential camp counselor classifications, to reflect the correct class titles.

**THE PEOPLE OF THE CITY OF LOS ANGELES
DO ORDAIN AS FOLLOWS:**

Section 1. Note 1 of SALARY NOTES APPLICABLE TO THE RECREATION AND PARKS DEPARTMENT of Section 4.61 of the Los Angeles Administrative Code is amended to read as follows:

NOTE 1. Employees of the Department of Recreation and Parks in the classifications of Residential Camp Counselor (Code 2421) and Senior Residential Camp Counselor (Code 2427), when so assigned, shall receive salary at the flat rate prescribed in Schedule "A" of Section 4.61 of the Los Angeles Administrative Code. The salary rate shall constitute full compensation for each half-day or day worked, and overtime would not be applicable notwithstanding provisions of Section 4.114 of the Code.

Sec. 2. This ordinance shall be operative upon publication pursuant to Charter Section 252(g).

Sec. 3. The City Clerk shall certify to the passage of this ordinance and have it published in accordance with Council policy, either in a daily newspaper circulated in the City of Los Angeles or by posting for ten days in three public places in the City of Los Angeles: one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall; one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall East; and one copy on the bulletin board located at the Temple Street entrance to the Los Angeles County Hall of Records.
