PERSONNEL AND ANIMAL WELFARE COMMITTEE REPORT and ORDINANCES FIRST CONSIDERATION relative to amending Ordinance No. 184251 (2015-16 to 2017-18 Fiscal Year Salaries and Benefits) to make various technical changes.

Recommendations for Council action, SUBJECT TO THE APPROVAL OF THE MAYOR:

1. PRESENT and ADOPT the following ORDINANCES amending Ordinance No. 184251 (2015-16 to 2017-18 Fiscal Year Salaries and Benefits):
 - a. Ordinance dated January 25, 2018 to delete the obsolete classification of Electrical Tester (Class Code 7513).
 - b. Ordinance dated January 25, 2018 to change the class code number of Police Administrator, in accordance with action by the Civil Service Commission, from Class Code 9183 to 9196.
 - c. Ordinance dated February 15, 2018 to reflect pay grade changes for the classes of Accountant (Class Code 1513), Airport Police Captain (Class Code 3228), Art Instructor (Class Code 2452), Chemist (Class Code 7833), Day Camp Director (Class Code 0835), Recreation Assistant (Class Code 2498), Recreation Instructor (Class Code 2499), Sanitation Wastewater Manager (Class Code 4128), and Systems Analyst (Class Code 1596), in accordance with applicable Memoranda of Understanding (MOUs).
2. AUTHORIZE the City Administrative Officer (CAO) and Controller to correct any clerical errors, or, if approved by the City Attorney, any technical errors in the above Ordinances.

Fiscal Impact Statement: The CAO reports that there is no cost associated with any of the technical changes reflected in the Ordinances amending Ordinance No. 184251 (Schedule A of Los Angeles Administrative Code Section 4.61).

Community Impact Statement: None submitted.

Summary:

On March 21, 2018, your Committee considered March 7, 2018 CAO and January 29, 2018 and February 26, 2018 City Attorney reports and three Ordinances relative to amending Ordinance No. 184251 (2015-16 to 2017-18 Fiscal Year Salaries and Benefits) to make various technical changes. According to the CAO, the classification of Electrical Tester (Class Code 7513) was part of a class consolidation by the Civil Service Commission (CSC) on August 13, 2009, which included changing the class code number of Electrical Tester from 7513 to 7512. The Electrical Tester class has been used exclusively by the Los Angeles Department of Water and Power (LADWP), and as such was listed in Schedule B of LAAC Section 4.900.1. Subsequent CSC action changed the class title to Electrical Test Technician (Class Code 7512), which was reflected in the most recent Schedule B (LADWP class listing) Ordinance submitted to the City Council. The former class and code number of Electrical Tester (Class Code 7513) is obsolete and should be deleted from the LAAC Section 4.61 Schedule A class listing.

On August 22, 2002, the CSC approved a class consolidation involving the classification of Police Administrator, which included changing the class code number of Police Administrator from Class Code 9183 to Class Code 9196. It was recently discovered that this change in class code number had not been reflected in the Schedule A classification listing in LAAC Section 4.61. Finally, an Ordinance is required to make various changes in pay grade designations or deletions in the LAAC Section 4.61 Schedule A class listing to conform to changes negotiated in recent MOUs,

After consideration and having provided an opportunity for public comment, the Committee moved to recommend approval of the three Ordinances as detailed in the above recommendations. This matter is now submitted to Council for its consideration.
