

ORDINANCE NO. 184851

An ordinance amending Note 3 of Salary Notes Applicable to the City Clerk's Elections Division in Section 4.61 of the Los Angeles Administrative Code, pertaining to stipends for Precinct Board Clerks and Inspectors, to provide clarifying language and increase the stipend amount for pre-election training sessions.

**THE PEOPLE OF THE CITY OF LOS ANGELES  
DO ORDAIN AS FOLLOWS:**

Section 1. NOTE 3 of SALARY NOTES APPLICABLE TO THE CITY CLERK'S ELECTIONS DIVISION of Section 4.61 of the Los Angeles Administrative Code is amended as follows:

DELETE:

**NOTE 3.** In order to facilitate poll worker training, timely set up of polling places and communications with field staff on election days, the City Clerk is authorized to pay Precinct Board Inspectors and Precinct Board Clerks the stipends shown below in addition to the salary listed in Schedule "A" of the LAAC 4.61:

ADD:

**NOTE 3.** In order to facilitate poll worker training, timely set up of polling places and communications with field staff on election days, the City Clerk is authorized to pay individuals who are hired in the classifications of Precinct Board Clerk (Code 0745) and Precinct Board Inspector (Code 0746) the stipends shown below in addition to the salary listed in Schedule "A" of the LAAC 4.61:

Sec. 2. Paragraph e of NOTE 3 of SALARY NOTES APPLICABLE TO THE CITY CLERK'S ELECTIONS DIVISION of Section 4.61 of the Los Angeles Administrative Code is amended as follows:

DELETE:

e. Pre-election training (If attend training and work on election day) \$25/session

ADD:


e. Pre-election training (If attend training prior to election day and work on election day) \$40/session

Sec. 3. This ordinance shall be operative upon publication pursuant to Charter Section 252(g).


Sec. 4. The City Clerk shall certify to the passage of this ordinance and have it published in accordance with Council policy, either in a daily newspaper circulated in the City of Los Angeles or by posting for ten days in three public places in the City of Los Angeles: one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall; one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall East; and one copy on the bulletin board located at the Temple Street entrance to the Los Angeles County Hall of Records.


