ARTS, PARKS, HEALTH, AGING AND RIVER COMMITTEE REPORT relative to the status of various projects connected with the Los Angeles River Revitalization Master Plan (LARRMP).

Recommendations for Council action:

1. NOTE and FILE the May 7, 2014 Bureau of Engineering (BOE)/Los Angeles River Project Office relative to the status of various projects connected with the LRRMP.
2. INSTRUCT the BOE/Los Angeles River Project Office to incorporate into its monthly report directions and recommendations on all pending items, outlined separately from the list of active projects, that the Arts, Parks, Health, Aging and River (APHAR) Committee should consider.
3. INSTRUCT the BOE/Los Angeles River Project Office to report at the next regular meeting of the APHAR Committee in regard to all pending State legislation that will have any impact on the Los Angeles River.
4. INSTRUCT the BOE/Los Angeles River Project Office to provide an update in regard to the Army Corps of Engineers' Los Angeles River Ecosystem Restoration Feasibility Study with said report to include:
 - a. A description of the project's current status.
 - b. A description and analysis with recommendations of what actions the City needs to take to ensure that the full scope of the Army Corps of Engineers' Los Angeles River Ecosystem Restoration Feasibility Study is adhered to, as directed by the Resolution adopted by Council on August 23, 2013 (Council File No. 10-0270-S3).

Fiscal Impact Statement: The BOE/Los Angeles River Project Office reports that its May 7, 2014 report is for informational purposes only and there is no fiscal impact anticipated.

Community Impact Statement: None submitted.

Summary:

On May 12, 2014, your Committee considered a May 7, 2014 BOE/Los Angeles River Project Office report relative to the LARRMP. According to the BOE, pursuant to Council File No. 07-1342, Council directed the BOE to establish the Los Angeles River Project Office and act as project manager in facilitating implementation of the LARRMP. Representatives from the project office provided an overview of current ongoing projects and answered questions from the Committee. After consideration and having provided an opportunity for public comment, the Committee moved to note and file the BOE report and make additional recommendations as detailed above in Recommendation Nos. 2-4. This matter is now submitted to Council for its consideration.
