ARTS, PARKS, HEALTH, AGING AND RIVER COMMITTEE REPORT relative to the status of various projects connected with the Los Angeles River Revitalization Master Plan (LARRMP).

Recommendations for Council action:

1. NOTE and FILE the June 5, 2014 and September 3, 2014 Bureau of Engineering (BOE)/Los Angeles River Project Office reports relative to the status of various projects connected with the LARRMP.
2. INSTRUCT the BOE/Los Angeles River Project Office to work with the Army Corps of Engineers and report in regard to the 408 permit process.

Fiscal Impact Statement: The BOE/Los Angeles River Project Office reports that its June 5, 2014 and September 3, 2014 reports are for informational purposes only and there is no fiscal impact anticipated.

Community Impact Statement: None submitted.

Summary:

On September 8, 2014, your Committee considered June 5, 2014 and September 3, 2014 BOE/Los Angeles River Project Office reports relative to the LARRMP. According to the BOE, pursuant to Council File No. 07-1342, Council directed the BOE to establish the Los Angeles River Project Office and act as project manager in facilitating implementation of the LARRMP. Representatives from the project office provided an overview of current ongoing projects and answered questions from the Committee. After consideration and having provided an opportunity for public comment, the Committee moved to note and file the BOE report and make additional recommendations as detailed above in Recommendation No. 2. This matter is now submitted to Council for its consideration.
