The Pipeline Franchise Revenue portion of the Real Property Trust Fund provides funding for infrastructure improvements within each Council District.


Council District 14 previously allocated funding (CF 14-0876) for beautification projects within Council District 14; however, there is a need for additional funds to finance the beautification projects.

I THEREFORE MOVE that \$45,000 in the Pipeline Franchise Revenue portion of the Council District 14 Real Property Trust Fund No. 696 be transferred/appropriated/allocated to the Department of Public Works, Bureau of Street Services (BSS) Fund No. 100, Department 86, Account 001010-Salaries, General, to perform beautification services in CD 14; and,

I FURTHER MOVE that the Bureau of Street Services (BSS) be instructed to perform the beautification work using direct costs with CTO and fringe costs only.

I FURTHER MOVE that the Bureau of Street Services be authorized to make any technical corrections or clarifications as necessary to the above instructions in order to effectuate the intent of this Motion.
