**Subject: APPROVAL FOR ALTERNATIVE DELIVERY METHODS AND COMPETITIVE  
SEALED PROPOSAL SELECTION PROCESS**

In accordance with Section 371(b) of the City Charter, the Board of Airport Commissioners transmits for your approval the use of Alternate Project Delivery Methods and the Competitive Sealed Proposal Selection Process to let Design-Build, Design-Build-Operate and Maintain, and Construction Manager At Risk contracts for delivery of select Capital Improvements Projects related to the LAX Landside Access Modernization Program at Los Angeles International Airport.

*RECOMMENDATION FOR CITY COUNCIL*

1. ADOPT Resolution No. 25681 which was approved by the Board of Airport Commissioners at their meeting held on April 16, 2015.
2. CONCUR in the Board of Airport Commissioners' action authorizing the Executive Director to let Design-Build, Design-Build-Operate and Maintain, and Construction Manager at Risk contracts for delivery of select capital improvement projects related to the LAX Landside Access Modernization Program at Los Angeles International Airport pursuant to the Competitive Sealed Proposal selection process.
3. Request that the City Council adopt an ordinance submitted by the City Attorney.
4. FIND that this action is exempt from the California Environmental Quality Act (CEQA) pursuant to Article II, Section 2.m of the Los Angeles City CEQA Guidelines.
