The Los Angeles City Council will conduct a Public Hearing relative to the City Council's intention to confirm, levy and collect annual assessments totaling \$25 million for fiscal year 2015-16 to acquire land and develop, improve, restore and maintain parks and recreational facilities for the Proposition K: L.A. for Kids Program (City of Los Angeles Landscaping and Lighting District 96-1, formed pursuant to the provisions of the Landscaping and Lighting Act of 1972 (Division 15, Part 2, Streets and Highways Code, State of California).
The hearing will be held on **June 3, 2015, at 10:00 a.m.**, or as soon thereafter as the matter can be heard, in the **John Ferraro Council Chamber, Room 340, City Hall, 200 North Spring Street, Los Angeles, CA 90012.**
