Fiscal Impact Statement: None submitted by the City Clerk. Neither the City Administrative Officer nor the Chief Legislative Analyst has completed a financial analysis of this report.

SUMMARY

In a report to the Mayor and Council dated October 2, 2014, the City Clerk states that the fund balance for the Council District 15 LAPD Harbor Division Police Assistance Trust Fund No. 888 was \$12,834.90 as of June 30, 2013. The Fund realized net revenue in the amount of \$154.79, and total expenditures and encumbrances in the amount of \$0.00, leaving a balance of \$12,989.69 as of June 30, 2014. According to the City Clerk, the Fund was established in 1995 for the receipt, retention, and disbursement of gifts, contributions and bequests for assistance in the operation of the Los Angeles Police Department's Harbor Division.

At its meeting held December 12, 2014, the Public Safety Committee recommended that Council approve the City Clerk's report.
