When I first immigrated to the United States from India, I purchased this hotel with the hope of building a better life for my family. Over the years, this business has been the foundation for our livelihood and has allowed us to contribute to the community.

The proposed wage ordinance puts my family's future at serious risk. As a small, independent hotel owner, I cannot afford such a significant increase in wages. Our business is already struggling as tourism in Los Angeles has not fully recovered, and our guests are primarily locals looking for affordable accommodations.

If this ordinance passes, we won't be able to raise rates without losing our guests, who are extremely pricesensitive. Larger hotels with more amenities can charge higher rates, but for small, budget properties like mine, this is not an option.

This wage increase would force us to close our doors, leaving my family without our primary source of income and my employees without jobs. My family's entire livelihood depends on this business, and this ordinance threatens to take that away.

My name is Payal Patel, and I am the proud owner of the Motel 6 located at 906 S. Alvarado St., Los Angeles, CA 90006. As an immigrant woman and small business owner, I have dedicated my life to building this business, which provides affordable accommodations to the local community and supports my family and employees.

As a franchised property, my Motel 6 is governed by strict brand standards that limit us to a single revenue stream: room rates. We are prohibited from charging for services like Wi-Fi, TV, phones, or breakfast. This makes it

impossible to offset the additional costs that would come with the proposed wage ordinance.

Our guests are primarily locals, as tourism has yet to return to Los Angeles after the pandemic, and it does not appear to be recovering anytime soon. Many of our guests are extremely price-sensitive and rely on affordable lodging options like ours. If we were forced to raise rates to cover increased payroll costs, our guests would seek out higher-end hotels that offer significantly more amenities at comparable prices.

This wage ordinance unfairly burdens small, family-owned hotels like mine, which do not have the resources or revenue streams of larger, corporate-owned properties. If this ordinance passes, I will have no choice but to close my business, default on my loans, and lay off my employees—many of whom are also from immigrant families who rely on this job to make a living.

For over 30 years, immigrant-owned and operated businesses like mine have been the backbone of the Los Angeles lodging industry. We have contributed millions in transient occupancy taxes and provided affordable accommodations to residents and visitors alike. This ordinance does not reflect the values of fairness or opportunity that drew my family to this country.

I urge you to consider an exemption for hotels with fewer than 150 rooms. Small, independent hotels cannot be held to the same standards as larger hotels with far greater resources. Without this carve-out, this ordinance will devastate family-owned businesses like mine and erode the affordable lodging options that so many residents depend on.

Thank you for your time and consideration. I hope you will stand with small, immigrant-owned businesses and make a decision that protects our livelihoods and communities.
