To most of the employees, we refuse the Healthcare and if we deny their Medical insurance, we must fill out a waiver to the city of Los Angeles to receive their monthly stipend. Full time employees will receive \$100 and part time will receive \$50. They might have found a loophole around this just to confuse the employees. I see the unfairness in the email they have sent out to me and my colleagues and we feel they are using this tactic just to not pay the full \$30.15. Its unjust and in other words, greedy.

As a Los Angeles resident, I am outraged to learn that hotel and airline corporations are attempting to cut their employees' wages and healthcare by cynically wielding a business tax repeal initiative as blackmail against the City.

Corporations like Delta, United and the American Hotel & Lodging Association recently received approval to circulate an initiative petition that would eliminate all business taxes, leaving a \$742 million annual hole in the General Fund—effectively, this is the equivalent of defunding the fire department. Worse, the plan is simple blackmail: agree to cut the Olympic Wage or we'll destroy the city's budget.

Not only that, an owner from one of these corporations was seen at a Kendrick Lamar concert back in April 2025. A former employee that the owner had laid off served him a beer, and the owner claimed that he was going through a financial hardship to both the former employee and at City Hall. If the owner had a financial hardship, how could the owner have afforded Kendrick Lamar tickets or did the owner take a bribe from someone above him?

This is outrageous. I will squabble up like Kendrick's lyrics at City Hall to ensure that we keep the living wage. We will not bend the knee to millionaires and billionaires unlike this political climate in the United States. These millionaires and billionaires are nothing without us.

These same corporations along with other tourism businesses already spent over \$2.5 million in their unsuccessful bid this summer to overturn the Olympic Wage by referendum. Both Delta and United Airlines's CEOs received \$27.1 and \$33.9 million in compensation in 2024 respectively, and yet they are demanding again that tourism workers be denied healthcare and the ability to pay rent.

Angelenos will not be bullied into abandoning tourism workers at a time when LA is poised to host the world's largest mega-events.

LA City Council and Mayor Bass took a historic step in passing the Olympic Wage in May 2025. This policy, now finally implemented, will transform the lives of thousands of working families and their communities over the coming years. But any delay of wages and healthcare will be devastating to workers. We cannot allow billionaire corporations to turn us back.

We urge you to stand with workers and reject corporate blackmail.
