Dear Council members:

I just spent one year and over \$50k updating my ADU per HOME-SHARING LA's demand that I obtain a Certificate of Occupancy so I may continue a STR permit, that's provided me the income needed to live in my home since 2016, when I refurbished my garage for this purpose.

I received my LADBS C. of O. November 8 and am now informed through an advocacy group that the LACC and, LA PLANNING COMMISSION / HOME-SHARE, are trying to legislate me out of my home, purchased in 2010, at a committee meeting December 4, 2024.

As a native Angeleno, I've thrived in the entertainment business and given back, in taxes and employment, for 40 years; many of them very profitable. But my industry has slunk into a recession due to Covid, strikes and structural change, to now resemble a memory of its more lucrative years, with the rich getting richer and the middle and lower-mid classes squeezed out, with diminishing incomes and, potentially, housing. There are fewer entertainment jobs and those that do exist, except at the top, pay less than they did 5 years ago.

The VERY issues our Mayor and this City Council state is of urgent concern — homelessness — is also happening in a subtle, insidious way to the "little people," (e.g., retirees, part-time workers or forcibly unemployed), impacted by this decade's events and thus leaving our great City. I see this happening every day. My own business has diminished dramatically.

Wasn't HOME-SHARING codified for home-owners, as well as visitors? Wasn't the point of the "gig" economy to help people like me remain in my home by earning extra income? All I see in this agenda are the ways to increase fines and penalize the bad actors. There is nothing to find in your agenda that helps the honest home-owners get through the bureaucratic maze that is the Home-Sharing platform — nothing at all to simplify and streamline the process for those of us who have contributed to this City for decades. **All I see are unnecessary roadblocks.**

Will you please show some concern for us honest brokers, **also your constituents**, and let us live in peace with a functional, friendly HOME-SHARE platform to enable us the added income we need to remain in our homes, spend our money locally, where I can tell you its needed, and keep this City from further deterioration and polarization? More good taxpayers will move.

I implore you, respectfully, to continue allowing STR's for ADU's which have C.of O.'s and keep the Extended Home-Share in place for those of us who follow your rules. It all works well if you ferret out those who ignore the rules. I cannot fathom why my City would try to penalize those of us who do.
