Dear Councilmembers Raman, Blumenfield, Harris-Dawson, Rodriguez, and Lee:

As the daughter of a senior homeowner who has had her ability to utilize home sharing to help cover her expenses when she has been hospitalized or traveled to see family, I am asking that the HSO be revised to allow rent-stabilized homes/duplexes that are permanently occupied by family should be able to register for limited home sharing.

I believe that the current ordinance is in violation of federal law regarding disparate impact as it prevents long-term homeowners who are often senior citizens in minority/economically disadvantaged communities from benefiting from renting their homes for short times to supplement their income. This was the original intent of home sharing (before it became a de-facto hotel business) and it is unfair that our oldest residents are being sidelined for gentrifying investors who tear down the historic (rent-controlled) buildings in our communities and build new places that can then be registered and profited off of, cutting available affordable housing in our neighborhood.

I further ask that you:

OPPOSE Planning's proposed amendment to the HSO to prohibit Home-Sharing in ADUs.

OPPOSE Planning's proposed amendment to the HSO to disallow the Extended Home-Sharing permit.
