To the City Council Members and their staff, the Mayor's office, and the Planning Department:

The per-night fee should not be added at this time for the following reasons:

-Hosts are already struggling due to Covid, and have been losing significant amounts of bookings and income. This is the worst possible time to raise fees. For the average host this will result in an additional yearly fee between \$320 - 855 and possibly as high as \$1069 on top of the current \$850 to host year-round.

-The NBS report stated the number of registrations between July 1, 2019 - January 31, 2020 but projected the data from Feb 1 thru June 30. The report was submitted August 5th. Why didn't they use actual data? Wouldn't actual data from the last 10 months since Feb 1 be more accurate?

-The number of nights booked does not correlate to the costs of overseeing the program. We recommend that they come back with a report that outlines actual registration data and Planning's actual costs.

-Currently, calls and emails to planning go unanswered and it takes days if not weeks for a response. Numerous mistakes have been made with the Extended Home-Sharing Permit registration process with listings being blocked even after payments have been made resulting in income loss for hosts and unnecessary additional stress. Planning is estimating that they need \$3.6M in staffing costs. This amount is top-heavy with Senior Planners at high salaries when what is needed is administrative clerks.

-Planning also estimates that it takes them 5 hours at \$183 an hour to process the Extended Home Sharing Permit. That needs explaining given the high volume of mistakes being made.

-NBS says that this type of nightly fee structure is not an industry standard and has only been adopted by one other city. They did not make a compelling case for why that should be enacted here.

-The \$182,287 for the "24/7 hotline" also needs to be reassessed. That line is answered by a person, but a person that knows absolutely nothing about enforcement in Los Angeles who says "I will pass your message along to the proper authorities". They are unable to answer any questions or offer any help. This "hotline" is no more than a glorified voice machine that could be handled at a fraction of the cost.

Being that this is the worst possible time to raise fees during a national pandemic and the fact that this report is sadly lacking real data with which to make its determination, we ask that you delay this decision to a later date when actual data can be analyzed and the emergency order has lifted. Instead, we ask that you turn your attention to pushing thru the legislation to allow RSO Owner-Occupied home-sharing, which you voted unanimously to approve a year ago but has languished without your further attention at the expense of so many mom and pop hosts.
