I am a host that has been deeply affected by the recent changes in home sharing policies. I have not had any work since the pandemic hit, and it was my airbnb that kept me afloat and paying my mortgage. I've recently been forced into a 30 day minimum rental stay category, which is very stressful to do at this time with the current pandemic eviction laws in place.

There are several airbnb's where the guest refuses to leave and can claim tenant rights.

Since turning to 30 days, I've had almost every guest request to go off platform to avoid fees and taxes. Increasing the fees will only further people going off platform and the city not getting tax money for the stays. This is hurting homeowners, and potential visitors to L.A. who end up not able to visit our city because the rates are too high.

To the City Council Members and their staff, the Mayor's office, and the Planning Department:

The Per-night tax is an onerous, regressive tax that discriminates against lower-income hosts. The tax is the same for a \$30 a night room as it is for a \$500 a night home.

This is a blatant effort to extort more money from hosts due to the City's short-sighted and deeply flawed Home-Sharing Ordinance reducing Occupancy Tax revenue.

That the City Council is attempting to do this in the midst of a global pandemic that has already drastically reduced the host's earnings is shameful.

The City should be exploring ways to help its small businesses rather than imposing more draconian fees to penalize them. Currently, a host with a 90% occupancy rate is already paying more than \$1,000 in permit fees. This unnecessary charge will inflate that an additional \$950 at a time when many hosts are struggling to stay afloat.
