I am writing to express my concern about the \$2.93 per night increase.

I am in Paul Koretz's district.

To add an \$2.93 a night would be \$1069.00 a year, which is a lot.

I just paid \$800.00 to extend home share. I also already paid \$89.00 for the initial 180 nights.

In addition, getting signed up did not go smoothly either.

I provided my driver's license and a copy of my home tax bill on September 16th, 2019 as required. Great, I was up and running with a license #. Then I received a letter sometime in May stating I need a license # to do short term rentals. So I call the city planning department. I gave them my license # and they basically say, then everything is fine.

Then my airbnb is shut down in August 2020. I don't even know why. Trying to get someone from City planning on the phone was not easy. They said the home tax bill was incorrect. I still do not understand what was wrong with it. It showed my home address with parcel# etc. and my name on it that I received in the mail from the city. They also had a copy of my driver's license showing my home address. They shut me down for 1 month & made me paid the \$89.00 again and said I had to re-apply. They also said that if I didn't do it right this time, I would not be allowed to do short term rentals. It was so frustrating and stressful. I was already shut down for 3 months due to covid. I was not able to get unemployment or anything from the Cares Act so needless to say this was a stressful time for me as I depend heavily on this income to pay my bills.

This addition is going to hurt me financially. It was hard enough to come up with the \$800.00 & the additional \$89.00.

If you increase the nightly booking then I will have to lower my price and I have already lowered them due to the pandemic.

This feels so wrong. I paid \$89.00 twice then I just paid the \$800.00 and now this. It feels well, dishonest.

My short term rental is at my home that I own and have lived for 21 years & it's important to Los Angeles's economy. The money I receive goes back into the local community unlike most of the hotels where their money goes overseas to a Shanghai corporation or out of State. Also I never have party's. (I wish I could say the same about my extremely noisy neighbors.)

I rely heavily on this income. These increases seem like they are never going to stop. I feel like we are always having to worry, what will be next.

I was also dishearten to hear that the 60 million you received from the 14% tax that was only instituted a few years ago did not go to helping the homeless like it was supposed to go. Instead the entire amount went to the police department as I was told by your planning department during one of the host/city meeting. This is quite sad as our homeless population is out of control.

In conclusion I hope you consider what I have expressed.

I hope you have a nice day and thank you for taking the time to read my correspondence.

To the City Council Members and their staff, the Mayor's office, and the Planning Department:

My name is Brad Greiner and I am the CEO of Open Air Homes. We manage about 50 high end residences in Los Angeles. We manage homes for a number of high net worth individuals who aim to spend between 3-6 months a year in Los Angeles, and chose to monetize their home and have it professionally managed when they are not in town. Our homeowners contribute greatly to the economic wellbeing of this city, and should be celebrated and not demonized for choosing to monetize their assets, with not only property taxes but high TOT taxes going into city coffers.

At Open Air Homes, we offer 24 hour a day communication on our website and have emergency plans in place with a security team on call should any guest in our home try to break the rules. We employ 26 employees full and part time with benefits, and have about 100 independent contractors that rely on this business to pay their bills.

I want to clearly state that this policy of charging a nightly fee will affect the lowest end short term rentals only, and is another example of creating a policy that negatively impacts the poor over the wealthy. This nightly fee is a rounding error for the homes we manage, yet is a significant amount for those who rely on this business to survive. If financial benefits were my only concern, I would be in full agreement that this fee should be added, but instead I am here to fight for those less fortunate, and while this policy will not affect my homeowner partners one way or the other, it is a policy that directly impacts those in financially dire situations. It is a bad policy at the worst possible moment, and is not well thought out.

We have been sticking to the 120 day guidelines for the homes under management, and have switched to a model of renting our homes for 30-90 day stints to account for this new type of traveler. **Your policies will not shut down this industry, it will only cause us to pivot our business model and continue to find ways to thrive in an industry that will be fully recognized in the coming 10 years.**

The best cities in the world have a combination of long term tenants, home buyers, hotels, hostels and short term rentals. The people have spoken and they want to continue traveling as locals instead of staying in small, stuffy hotel rooms in hotel zones. **It's up to you to come up with policies that address the inherent issues with short term rentals, like noise issues and 24 hour a day support for neighbors, instead of continually trying to regulate this business out of existence.**

I stand with HALA.

-Please do not increase home-sharing fees during a Pandemic.

-Focus instead on passing the amendment to allow RSO Owner-Occupied home-sharing.

- Focus instead on creating policies that fine hosts who do not take the necessary steps towards limiting parties in their homes. These homes are very easy to spot on sites like Airbnb, and enforcement of party homes would be good for the industry as a whole.

- There is a growing amount of residents that see value in short term rentals, both as travelers and as homeowners, and it is your job to find the appropriate balance so that Los Angeles can continue to welcome tourists from around the world who want something different than the antiquated hotel model experience.

Dear Councilmembers and Staff,

As you consider the per-night fee for home-sharing tomorrow, please consider the following:

1. The \$2.93 per-night fee doesn't sound like a lot, but if booked year-round that's an additional \$1065 on top of the \$850. Someone charging \$30 a night would pay a 17.5 per cent tax whereas someone charging \$300/nt would pay 1.75 per cent. That's not equitable. It should be a percentage fee not a flat fee.
2. The report by NBS ([read here](#)) states that as of Jan 31, 2020 there were 5,963 registered hosts. However, for some reason they estimated the number of registrations between February - June 2020 even though the report was submitted in August.


But in a declaration under penalty of perjury to the Superior Court of the State of California by Vince Bertoni on June 22, 2020, (attached, p7, item 22) he stated that as of June 15th, 2020 there were 3,947 hosts.

3. Planning is asking for 3.9M to administer this program top heavy with Senior Planning salary levels based on a projection in the report of 7,426 hosts. But the Head of Planning says there are 3,947 hosts that host only up to 120 nights and in a call to Planning this week we learned that only 350 host year round. The per night charge must be based on clear data.

HALA asks that you reconsider the nightly fee to be based upon a percentage rather than a flat fee and that you not determine that percentage until this conflicting data between the Head of Planning and the Fee Study. But more importantly, we ask that you delay any increase in fees until the emergency order has lifted. By now you have received over 80 emails opposing this motion.

I am writing to express my concern about the \$2.93 per night increase.

I am in Paul Koretz's district.

To add an \$2.93 a night would be \$1069.00 a year, which is a lot.

I just paid \$800.00 to extend home share. I also already paid \$89.00 for the initial 180 nights.

In addition, getting signed up did not go smoothly either.

I provided my driver's license and a copy of my home tax bill on September 16th, 2019 as required. Great, I was up and running with a license #. Then I received a letter sometime in May stating I need a license # to do short term rentals. So I call

the city planning department. I gave them my license # and they basically say, then everything is fine.

Then my airbnb is shut down in August 2020. I don't even know why. Trying to get someone from City planning on the phone was not easy. They said the home tax bill was incorrect. I still do not understand what was wrong with it. It showed my home address with parcel# etc. and my name on it that I received in the mail from the city. They also had a copy of my driver's license showing my home address. They shut me down for 1 month & made me paid the \$89.00 again and said I had to re-apply. They also said that if I didn't do it right this time, I would not be allowed to do short term rentals. It was so frustrating and stressful. I was already shut down for 3 months due to covid. I was not able to get unemployment or anything from the Cares Act so needless to say this was a stressful time for me as I depend heavily on this income to pay my bills.

This addition is going to hurt me financially. It was hard enough to come up with the \$800.00 & the additional \$89.00.

If you increase the nightly booking then I will have to lower my price and I have already lowered them due to the pandemic.

This feels so wrong. I paid \$89.00 twice then I just paid the \$800.00 and now this. It feels well, dishonest.

My short term rental is at my home that I own and have lived for 21 years & it's important to Los Angeles's economy. The money I receive goes back into the local community unlike most of the hotels where their money goes overseas to a Shanghai corporation or out of State. Also I never have party's. (I wish I could say the same about my extremely noisy neighbors.)

I rely heavily on this income. These increases seem like they are never going to stop. I feel like we are always having to worry, what will be next.

I was also dishearten to hear that the 60 million you received from the 14% tax that was only instituted a few years ago did not go to helping the homeless like it was supposed to go. Instead the entire amount went to the police department as I was told by your planning department during one of the host/city meeting. This is quite sad as our homeless population is out of control.

In conclusion I hope you consider what I have expressed.

I hope you have a nice day and thank you for taking the time to read my correspondence.

I've been able to meet great people and introduce them to all types of shops, restaurants and small businesses' LA has to offer. When the city's home-sharing went into effect last year, I gladly signed up and paid both registration fees (over \$900) immediately. In the midst of a pandemic, another \$2.93 per night fee is an untimely blow to hosts. My Airbnb helps me pay for mortgage and property taxes, but adding more fees and taxes is unreasonable. I write to ask that you reconsider the nightly fee to be based upon a percentage rather than a flat fee and that you not determine that percentage until this conflicting data between the Head of Planning and the Fee Study is resolved. But more importantly, we ask that you delay any increase in fees until the emergency order has lifted.

The \$2.93 per-night fee doesn't sound like a lot, but if booked year-round that's an additional \$1065 on top of the \$850. Someone charging \$30 a night would pay a 17.5% tax whereas someone charging \$300/nt would pay 1.75%. That's not equitable. It should be a percentage fee not a flat fee.

I am a homeowner who depends on the rental income while I am still required to travel for work. Please be considerate of those of us who require this income for survival!!

I write to ask that you reconsider the nightly fee to be based upon a percentage rather than a flat fee and that you not determine that percentage until this conflicting data between the Head of Planning and the Fee Study is resolved. But more importantly, we ask that you delay any increase in fees until the emergency order has lifted.

The \$2.93 per-night fee doesn't sound like a lot, but if booked year-round that's an additional \$1065 on top of the \$850. Someone charging \$30 a night would pay a 17.5% tax whereas someone charging \$300/nt would pay 1.75%. That's not equitable. It should be a percentage fee not a flat fee.

I am a homeowner who depends on the rental income while I am still required to travel for work. Please be considerate of those of us who require this income for survival!!

There are number of good reasons not to pass this per-night fee:

- 1) A portion of the fee, if not all of it, will be passed to renter and increase already high rent prices.
- 2) The cost of enforcement will make it a tax spent on collection with no benefit to constituents / LA economy. It will be a net dead-weight loss.
- 3) Since the majority of homeowners are LA based, it will be remove dollars otherwise spent locally. Potentially also reducing investment in maintenance and safety of rental units.
