I ask that you:

OPPOSE Planning's proposed amendment to the HSO to disallow the Extended Home-Sharing permit.

Currently I am back and forth to Canada and Los Angeles for work and for family obligations. My primary residence is my home in Los Angeles. This is my home. It will never be a long term rental. The extended sharing permit allows me a lot of flexibility for being able to make sure my house does not sit empty when my family and I are back and forth to Canada. Our next door neighbors rented out their home while they had a 5month work placement out of state. When they gave notice to their tenants that they were moving back into the Los Angeles home ( as per the legal agreement) the tenants stopped paying rent and refused to leave. It took a legal process and 5 months to finally get them out. All while (ironically) my neighbors had to pay to stay in a SHORT TERM RENTAL. I will never put my kids and myself in that situation with my home.

Please do not ruin this for the ones of us that are playing by all the rules. The extended permit offers us flexibility with travel and work.

AGREE that the Registration process is in dire need of streamlining. So many of us are having issues with city planning. My permit didn't go through after waiting for a response to my paperwork for over three months. (It was never processed) and my calendar was blocked for booking. The only way I could get help was to contact my city Council member. No one replies to the emails or voicemails in the planning department. There are hundreds of people online that have issues that can't be resolved. The renewals are taking forever. It seems like the planning department is looking for reasons to turn people down. Please don't punish us rule followers!!!

We need a better streamlined process for us rule followers. One of my documents as proof of primary residence was rejected. I am proud female business owner. My company was created in 2016. I have only been short term renting my house for a little over a year. The Planning Department turned down my paystub because I am the CEO of the company. So city planning thinks that I must have created a company in 2016 and paid payroll and taxes for 8 years with the hindsight that I would need to print a paystub in 2024?!!! Ludicrous. If my Corporation is ok with the State and the IRS how is it possibly not good enough for the home sharing department? Again, the time they took hunting down that information to find a reason to decline one document they could have spent returning emails and phone calls. Of course there was no one to contact to update to a different document.

The last thing I will mention is I OPPOSE THE POLICE PERMIT!!!!

AIRBNB ALREADY DOES BACKGROUND CHECKS ON HOSTS!!! Were you aware of that fact? If you have a criminal record Airbnb will not allow you to be a host. So this is an already solved problem considering most short term rentals are through AIRBNB. The city has failed abysmally at issuing permits so why would you choose to add another step?

Also, lastly please notice that the people showing up at meetings for the Airbnb restrictions are paid by places Like the Beverly Hotel and other Hotel groups.
