
Pacoima Beautiful is coordinating the acquisition of outdoor furniture and equipment for the Bradley Plaza project previously approved by the Council (CF 13-1592).

This effort is of special benefit for the residents of the City and for CD-7 and deserves financial assistance from the City.

Sufficient funds are available in the Council District 7 portion of the Street Furniture Revenue Fund which could allocated for this purpose.

I THEREFORE MOVE that \$10,000 in the Council District 7 portion of the Street Furniture Revenue Fund No. 43D Dept. 50 be allocated to Pacoima Beautiful for coordinating the acquisition of outdoor furniture and equipment for the Bradley Plaza project previously approved by the Council (CF 13-1592) that the Board of Public Works, Office of Accounting be authorized to make any payment to Pacoima Beautiful, or any other agency or organization, in the above amount for the above purpose, and to prepare and process any other document as may be required or appropriate for this purpose.
