A full Environmental Impact Report is necessary to determine the negative impact the Planet Home buildings will have on this old. established neighborhood. In particular, we are concerned about the aesthetics of the buildings and the removal of many trees. Large, old trees are one of the hallmarks of this neighborhood.
