

MOTION

The Council District AB1290 Fund provides funding for redevelopment and community services in various Council Districts.

There is a great need to support the community beautification and clean-up efforts of the Los Angeles Conservation Corps in Council District 1. This effort is of special benefit for the residents of the City and for CD-1 and deserves financial assistance from the City.


Sufficient funds are available in the CD-1 portion of the Council District AB 1290 Fund for this purpose.

I THEREFORE MOVE that \$45,000 in the AB1290 Fund No. 53P, Account No. 281201 (CD 1 Redevelopment Projects - Services) be transferred / appropriated to the Board of Public Works Fund No. 100-74, Account No. 3040 (Contractual Services) for the community beautification and clean-up efforts of the Los Angeles Conservation Corps in Council District One; and that the Public Works Office of Community Beautification be authorized to prepare the necessary document(s) with, and/or payment(s) to, the Los Angeles Conservation Corps, or any other agency or organization, as appropriate, in the above amount, and for the above purpose, subject to the approval of the City Attorney as to form, if needed; and that the Council member of the First District be authorized to execute any such document(s) on behalf of the City.

I FURTHER MOVE that the Department of Public Works be authorized to make any corrections, clarifications or revisions to the above instructions, including any new instructions, in order to effectuate the intent of this Motion, including any corrections and changes to fund or account numbers; said corrections / clarifications / changes may be made orally, electronically or by any other means.
