

ORDINANCE NO. 184052

An Ordinance of the City of Los Angeles changing the name of Center Street between Viewland Place and Knoll Drive and establishing the same as Eastview Little League Drive.

**THE PEOPLE OF THE CITY OF LOS ANGELES
DO ORDAIN AS FOLLOWS:**


Section 1. The City Council of the City of Los Angeles finds that the public interest, convenience and necessity require that the name of that certain public street, 60 feet in width, being the first Northerly/Southerly trending public street easterly of Pacific Avenue, lying between Viewland Place and Knoll Drive, or any portion of which may be or may have been named or known as or called Center Street be and the same is hereby changed to and established as Eastview Little League Drive.

Sec. 2. Pursuant to the provisions of Section 252 of the Charter of the City of Los Angeles, this Ordinance shall become effective upon publication.

Sec. 3. The City Clerk shall certify to the passage of this ordinance and have it published in accordance with Council policy, either in a daily newspaper circulated in the City of Los Angeles or by posting for ten days in three public places in the City of Los Angeles: one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall; one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall East; and one copy on the bulletin board located at the Temple Street entrance to the Los Angeles County Hall of Records.

I hereby certify that this ordinance was passed by the Council of the City of Los Angeles, **by a vote of not less than two-thirds** of all of its members, at its meeting of JAN 26 2016.



DECLARATION OF POSTING ORDINANCE

I, JUAN VERANO, state as follows: I am, and was at all times hereinafter mentioned, a resident of the State of California, over the age of eighteen years, and a Deputy City Clerk of the City of Los Angeles, California.
