PUBLIC WORKS AND GANG REDUCTION COMMITTEE REPORT relative to initiating the street name change process for Center Street between Viewland Place and Knoll Drive in San Pedro to be changed to Eastview Little League Drive.

Recommendations for Council action, pursuant to Motion (Buscaino - Parks):

1. INITIATE the street name change process to change the name of Center Street between Viewland Place and Knoll Drive in San Pedro to Eastview Little League Drive.
2. INSTRUCT the City Engineer to report to the Public Works and Gang Reduction Committee within 30 days on the necessary steps required to change the name of Center Street between Viewland Place and Knoll Drive in San Pedro to Eastview Little League Drive including fees, reports, ordinances, and expected implementation time-frame associated with the street name change.
3. INSTRUCT the Los Angeles Department of Transportation upon approval of the street name change to promptly fabricate and install new signs on Eastview Little League Drive.
4. INSTRUCT the Bureau of Engineering upon Council approval of the street name change to notify the Police Department Harbor Division and Fire Department Battalion Six Stations of the street name change and to update their computer-aided dispatch systems.

Fiscal Impact Statement: Neither the City Administrative Officer nor the Chief Legislative Analyst has completed a financial analysis of this report.

Community Impact Statement: None submitted.

SUMMARY

At the meeting held on April 15, 2015, your Public Works and Gang Reduction Committee considered a Motion (Buscaino - Parks) relative to initiating the street name change process for Center Street between Viewland Place and Knoll Drive in San Pedro to be changed to Eastview Little League Drive. An opportunity for public comment was held. After a brief discussion, the Committee moved to approve the recommendations contained in the Motion as detailed above. This matter is now forwarded to the Council for its consideration.

MOTION

There is a need to change the name of Center Street between Viewland Place and Knoll Drive in San Pedro to Eastview Little League Drive. A portion of Center Street is an island that is cut off from the remaining portion of Center Street (a major north/south thoroughfare through San Pedro) by the construction of Highway 47 and Vincent Thomas Bridge. As a result, over the years this separation has caused confusion and slowed emergency response. The requested name change will mitigate these problems.

I THEREFORE MOVE that the City initiate the street name change process to change the name of Center Street between Viewland Place and Knoll Drive in San Pedro to Eastview Little League Drive.

I FURTHER MOVE that the City Engineer report to the Public Works and Gang Reduction Committee within 30 days on the necessary steps required to change the name of Center Street between Viewland Place and Knoll Drive in San Pedro to Eastview Little League Drive including fees, reports, ordinances, and expected implementation time-frame associated with the street name change.

I FURTHER MOVE that the Department of Transportation be instructed upon approval of the street name change to promptly fabricate and install new signs on Eastview Little League Drive.

I FURTHER MOVE that upon Council approval of the street name change that the Bureau of Engineering be instructed to notify the Police Department Harbor Division and Fire Department Battalion 6 Stations of the street name change and to update their computer-aided dispatch systems.
