At our August 11, 2015, Board meeting, we voted 9-0-0 to support File No. 15-0524, which would grant up to five minutes, separate from general public comment, for a certified Neighborhood Council or Neighborhood Council Alliance representative to present the official view of the Neighborhood Council Board or Alliance on issues to the City Council, its committees, commissions, and Boards, and to receive priority as City entities and be called for comment before general public comment.

From our previous experience in attending the City Council, Council Committee meetings and Commission hearings, we have often found the current time limit to be too limiting to allow an adequate explanation of our reasons for supporting or opposing a proposal. This limitation does a dis-service to our stakeholders on whose behalf we are advocating our position.
