An ordinance amending Paragraph (c) of Subdivision 14 of Subsection B of Section 63.44 of Article 3 of Chapter VI of the Los Angeles Municipal Code to add Alma Park, located at the intersection of West 21st Street and South Meyler Street in San Pedro, to the list of City parks identified as being closed at sunset and open at sunrise.

**THE PEOPLE OF THE CITY OF LOS ANGELES  
DO ORDAIN AS FOLLOWS:**


Section 1. Paragraph (c) of Subdivision 14 of Subsection B of Section 63.44 of Article 3 of Chapter VI of the Los Angeles Municipal Code is amended by adding, in alphabetical order, a park to the list of City parks that are identified as being "Closed at Sunset, open at Sunrise," to read as follows:

Alma Park

Sec. 2. The City Clerk shall certify to the passage of this ordinance and have it published in accordance with Council policy, either in a daily newspaper circulated in the City of Los Angeles or by posting for ten days in three public places in the City of Los Angeles: one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall; one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall East; and one copy on the bulletin board located at the Temple Street entrance to the Los Angeles County Hall of Records.



## DECLARATION OF POSTING ORDINANCE


I, VERONICA COLEMAN-WARNER, state as follows: I am, and was at all times hereinafter mentioned, a resident of the State of California, over the age of eighteen years, and a Deputy City Clerk of the City of Los Angeles, California.
