

ORDINANCE NO. 183852

An ordinance amending Article 3 of Chapter 2 of Division 4 of the Los Angeles Administrative Code to rename the Class Titles of Class Codes 0108 and 9194 from "Member Productivity Advisory Commission" to "Member Innovation and Performance Commission" and from "Executive Director Quality and Productivity Commission" to "Executive Director Innovation and Performance Commission."

WHEREAS, the City Council, effective August 6, 1998, adopted Ordinance No. 172140 thereby amending Section 8.230 of the Los Angeles Administrative Code to rename the Productivity Commission as the Quality and Productivity Commission for the City of Los Angeles;

WHEREAS, the City Council, effective November 3, 2014, adopted Ordinance No. 183230 thereby amending Section 8.230 of the Los Angeles Administrative Code to rename the Quality and Productivity Commission as the Innovation and Performance Commission and making certain specified changes to the duties of the Commission; and

WHEREAS, the City Council desires to change the Class Titles of Class Codes 0108 and 9194 as set forth in Schedule A of Section 4.61 of the Los Angeles Administrative Code from "Member Productivity Advisory Commission" to "Member Innovation and Performance Commission" and from "Executive Director Quality and Productivity Commission" to "Executive Director Innovation and Performance Commission" to be consistent with the change in the name of the commission.

NOW, THEREFORE,

**THE PEOPLE OF THE CITY OF LOS ANGELES
DO ORDAIN AS FOLLOWS:**

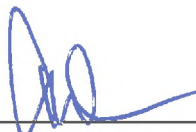
Section 1. Article 3 of Chapter 2 of Division 4 of the Los Angeles Administrative Code is hereby amended to rename the Class Title of Class Code 0108 in Schedule A of Section 4.61 to "Member Innovation and Performance Commission."

Sec. 2. Article 3 of Chapter 2 of Division 4 of the Los Angeles Administrative Code is hereby amended to rename the Class Title of Class Code 9194 in Schedule A of Section 4.61 to "Executive Director Innovation and Performance Commission."

Sec. 3. The City Clerk shall certify to the passage of this ordinance and have it published in accordance with Council policy, either in a daily newspaper circulated in the City of Los Angeles or by posting for ten days in three public places in the City of Los Angeles; one copy on the bulletin board located at the Main Street entrance to Los Angeles City Hall; one copy on the bulletin board located at the Main Street entrance to Los Angeles City Hall East; and one copy on the bulletin board located at the Temple Street entrance to the Los Angeles County Hall of Records.

DECLARATION OF POSTING ORDINANCE
