

**SUMMARY**

The Los Angeles Fire Department Foundation, Karen Wagener, 1875 Century Park East, Suite 200, Los Angeles, CA 90067, (310) 552-4139, has donated to the members of the Los Angeles Fire Department, 50 Apple iPads; 50 iPad cases and 50 iPad car chargers valued at \$29,067.50, grant request form attached. This donation will benefit the Department by providing iPads to all Command Staff officers for use in emergency tactical operations. Submitted in accordance with the Los Angeles Administrative Code, Article 12, Sections 5.111.3 and 5.111.4, which provides for the receipt of gifts and bequests of personal property to be utilized by the Fire Department, exceeding \$5000.00 in market value shall be submitted to the City Council for acceptance or rejection.

**RECOMMENDATION**

That the Board:

1. Receive this report in regard to the Los Angeles Fire Department Foundation donation for Apple iPads and accessories valued at \$29,067.50 to the Los Angeles Fire Department and transmit it to the City Council for approval/acceptance.
2. Instruct the Commission Executive Assistant to transmit this report to City Council in accordance with the Los Angeles Administrative Code, Ordinance 15514, Article 12, Section 5.111.4.

**FISCAL IMPACT**

There is no fiscal impact to the Department's budget from the acceptance of this donation. Donations provide the necessary needs of the Department's Command Staff to effectively manage emergency operations with the latest technology. Replacement or repair of items meeting City specifications and Fire Department business needs may be borne by General Fund, subject to budgetary constraints.
