

FIRST AMENDMENT TO CONTRACT NUMBER DA-4762
BETWEEN THE CITY OF LOS ANGELES AND
RIVERS & CHRISTIAN AT LOS ANGELES WORLD AIRPORTS

This **FIRST AMENDMENT** to **CONTRACT NUMBER DA-4762** ("Amendment") is made and entered into as of this _____ day of _____, 2015 by and between the **CITY OF LOS ANGELES**, a municipal corporation, acting by order of and through the Board of Airport Commissioners (hereinafter referred to as "City") and **RIVERS & CHRISTIAN** (hereinafter also referred to as "Consultant"),

RECITALS

WHEREAS, City and Consultant entered into the Los Angeles World Airports Contract Number DA-4762 ("Contract") for professional architectural design services; and

WHEREAS, the original term of the Agreement was for three (3) years commencing upon Consultant's receipt from City of a Notice -to- Proceed; and

WHEREAS, the Parties both agree to extend the term of the Contract for a period of two (2) additional years, for a total of five (5) years which will require the approval of both the Board of Airport Commissioners and the Los Angeles City Council; and

NOW, THEREFORE, in consideration of the promises and of the terms and covenants and conditions hereinafter contained to be kept and performed by the respective parties hereto, do mutually agree that the Contract is **HEREBY AMENDED AS FOLLOWS**:

AMENDMENT

Amendment Section 1. Section 2.0 of the Contract is hereby deleted in its entirety and replaced with the following:

Section 2.0 Term of Contract.

The term of this Contract shall be for a period of five (5) years commencing upon Consultant's receipt from City of a Notice-to-Proceed subject, however, to earlier termination as hereinafter specified in Section 24.0, Abandonment of Program and Cancellation of Contract or Suspension of Services.




