

ORDINANCE NO. 185423

An ordinance to rescind Ordinance No. 184,099, adopted on February 10, 2016, amending Sections 12.03, 12.04.A and 12.04.C of Article 2, Chapter 1 of the Los Angeles Municipal Code, and adding Section 12.04.06 to Article 2 of Chapter 1 of the Los Angeles Municipal Code to establish an "HI" Hybrid Industrial Live/Work Zone.


**THE PEOPLE OF THE CITY OF LOS ANGELES
DO ORDAIN AS FOLLOWS:**

Section 1. Ordinance No. 184,099, which established an "HI" Hybrid Industrial Live/Work Zone in the City's Zoning Ordinance, is repealed.

Sec. 2. The City Clerk shall certify to the passage of this ordinance and have it published in accordance with Council policy, either in a daily newspaper circulated in the City of Los Angeles or by posting for ten days in three public places in the City of Los Angeles: one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall; one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall East; and one copy on the bulletin board located at the Temple Street entrance to the Los Angeles County Hall of Records.


