SUBJECT: REPORT BACK REGARDING ONLINE NEIGHBORHOOD COUNCIL ELECTIONS

Honorable Members:

SUMMARY

In 2016, the Department of Neighborhood Empowerment (EmpowerLA) and, to a limited extent, the Office of the City Clerk (City Clerk), conducted 34 online Neighborhood Council (NC) Elections using a platform provided by Everyone Counts, Inc.¹ In general, the pilot program was successful, but several issues did arise that need to be addressed if online voting is to continue for future NC Elections, in either 2018 or 2019. Some of these issues were highlighted in EmpowerLA's report on the 2016 online voting pilot from January 17, 2017 (Council File 15-1022-S2).²

At the August 15, 2017, Health, Education, and Neighborhood Councils Committee, the City Clerk was instructed to report back on the issues related to online voting during the 2016 NC Elections. This report will address those and additional issues and present solutions that could be applied to future online elections, if the option is made available. This review also includes recommendations on how the City Clerk will manage voter registration information and data security for future online elections.

Finally, in this report, funding that was provided for the Fiscal Year 2017-18 NC Elections is discussed and the possible use of the remaining funds if the elections are held in 2019 instead and online voting is offered. Also included are recommendations for the City Attorney to draft the appropriate ordinances with the assumption that the elections will be moved to 2019.

ONLINE ELECTION ISSUES AND SOLUTIONS

The following issues and suggested solutions were identified by EmpowerLA and City Clerk staff, as well as the individual NCs that participated in the online voting pilot program. An assessment on each NC's online voting experience is available for review in EmpowerLA's January 17 report (Attachment E).

1. Delayed Voter Registration Portal

The intended voter registration portal through Everyone Counts was not completed and available until the last set of elections in June 2016. Although EmpowerLA developed a substitute registration portal using their QuickBase software as a provisional solution, this step lead to further delays and complications among staff. According to EmpowerLA, staff did not have a clear understanding of how their QuickBase solution worked, which led to verification errors and delays.

Proposed Solution: To successfully test and launch an updated and effective online voter registration system, the City Clerk, EmpowerLA, and Everyone Counts must review and develop detailed system specifications much earlier in the election process to allow for the necessary modifications. A full review of the voting process will also be conducted. Accordingly, it will be necessary to review the current contract with Everyone Counts to ensure that the required changes can be made. If NC Elections are postponed until 2019, the City Clerk recommends that this system review and modification process begin immediately.

2. Complicated Voter Verification Policies

Voter verification policies and procedures were in flux throughout the registration process, leading to staff confusion and unbalanced and excessive workloads, which lead to several errors. This issue was exacerbated by the fact that some NCs each have unique voter eligibility requirements, which can include complex documentation rules. In order to properly register a voter in an online, or traditional at-polls election, staff must be well-trained on specific NC rules. Additionally, NCs often change board structures and who is allowed to vote.

Proposed Solution: As with the specifications and development of an online voter registration system, comprehensive voter verification policies and procedures must be developed and completed very early in the election cycle to ensure that staff has enough time to train and become familiar with general and NC-specific eligibility requirements. Further, if complex documentation requirements are to continue, the City

Clerk may require a larger set of staff to process the incoming documents. This expansion may not be necessary if NCs adopt a self-affirmation verification model, which would only require voters to submit a photo identification. To that end, the City Clerk recommends that NCs participating in online elections adopt self-affirmation as their voter verification method.

3. Voter Apprehension

Voters were reluctant to upload sensitive documents to complete the voter registration process online. Unlike municipal, statewide, or federal elections, NC voters are often required to provide some form of documentation to establish their eligibility to vote in a given NC Election. In order to participate in an online election, all voters must provide some form of photo identification. As a result, many voters were hesitant to provide these documents online.

Proposed Solution: To ensure that voters exercise their right to vote and provide assurance that their required documents are kept secure, voters can be given the opportunity to register and vote at the polls on Election Day or at an early voting location before Election Day. It should be noted that voters who participate in self-affirmation elections would not be required more than a photo identification in order to register to vote. Minimizing the number and types of documentation required to register to vote may encourage online voter registration and provide greater assurance that their individual privacy is secure.

The "Pop-Up Polls" that EmpowerLA introduced in 2016 were, in part, for this reason. If online elections are continued for future elections, the City Clerk would continue a version of this program as part of an early registration/voting process.

4. Extensive Voter Assistance

<u>Voters required more assistance than expected to complete online voting registration and voting.</u> Although familiarity with online and mobile technology is common throughout the City, many voters had difficulty navigating the registration and voting process.

Proposed Solution: The City Clerk and EmpowerLA intend to enhance the voter outreach and education initiatives that were first developed and introduced for the 2016 online elections. These included How-To videos and multi-language instructions that were made available online and at the polls on Election Day. The City Clerk will compliment this education program with enhanced registration customer services and extensive staff and poll worker training. The latter will also include an emphasis on streamlining and expediting the registration processes at the polls. A revised early voting initiative would also provide voters that require assistance with the opportunity to register and vote with direct staff support.

5. Necessary Hardware Requirements

In addition to modifying Everyone Count's current registration and voting software, updated registration and voting hardware is necessary to enhance the voter's experience at the polls or early voting location. These updates should include, but are not limited to, identification card scanners to speed up the registration process and larger computer tablets to both register to vote and cast ballots.

VOTER REGISTRATION AND DATA SECURITY

As previously reported by EmpowerLA, voter registration information was unintentionally released to candidates of the 2016 Studio City NC Election. This information included sensitive personal documents that voters submitted to prove their eligibility to vote. According to EmpowerLA, this issue was addressed and resolved with the implementation of Everyone Count's voter registration system, which restricted staff access to sensitive voter registration information.

If online elections are to continue, the City Clerk would oversee the online voter registration process and will meticulously evaluate the newly upgraded voter registration and online voting system. This evaluation process will ensure the system is secure, authentic, verifiable, auditable, user-friendly, and meets the election requirements set forth by the City Clerk, EmpowerLA and the City Attorney. The City Clerk will also require all previously registered voters to verify their current registration information to ensure that they are still eligible to participate in future online elections.

In addition, the City Clerk will limit those who will have access to voter information and restrict what information can be disclosed. Only the City Clerk's and Everyone Count's election staff will have access to the voter information stored in the online voter registration system. Currently, anyone requesting access to voter registration information may only have access to the voter's name and the ballot(s) they were issued. Personal information, such as home addresses, phone numbers, birth dates, signatures, and email addresses are withheld by staff when fulfilling public records requests. The City Clerk will evaluate these disclosure guidelines and consult with the City Attorney on the additional protections that can be provided to all voters who participate in NC Elections, whether they are conducted online or at the polls.

Please note that the department may consider building an in-house voter registration system if it is found to be more cost effective, have superior integration, and can be customized to meet NC's needs. An in-house solution should also be capable of meeting the adjusted voter registration security requirements, including the proper disposal of sensitive voter documentation.

FUNDING

The City Clerk was allocated funds to conduct at-poll NC Elections in Fiscal Year 2017-18. The uncommitted balance of funds allocated for this purpose is \$541,120. If online elections are to be offered in 2018, an additional \$681,950 would be required for EmpowerLA and the City Clerk. Details on this funding requirement can be reviewed in EmpowerLA's report submitted to this committee dated August 3, 2017.

Currently, only 50 NCs are set up for online elections. If the NC Elections are held in the spring of 2019 and online elections are offered, the \$541,120 can be partially used to build out the remaining NCs. If online elections are to be offered in 2019, it is recommended that the City Clerk work with Everyone Counts this year to build out the remaining 47 NCs so that online elections can be offered to every NC in 2019. (Please note this reflects only the current number of NCs which may increase by 2019). The remaining funds could be transferred to EmpowerLA for outreach if the Council and Mayor so choose.

ORDINANCE CHANGES

Should the NC Elections be moved to 2019, and all subsequent elections to odd numbered years, the City Attorney can be requested to draft the appropriate ordinance to reflect this change. While term limits can be addressed individually by NCs in their election stipulation worksheets, it may make sense to address this one-time extension in the ordinance.

RECOMMENDATIONS

That the City Council adopt the following recommendations:

- 1. Instruct the Office of the City Clerk and EmpowerLA to review and modify the online voter registration and voting system for future online Neighborhood Council Elections.
- 2. Instruct the Office of the City Clerk and EmpowerLA, in consultation with the Office of the City Attorney, to develop guidelines for the processing and security of Neighborhood Council voter registration information.
- 3. Authorize the City Clerk to use up to \$250,000 in funds appropriated for the Fiscal Year 2017-18 Neighborhood Council Elections for the online build out/set up of the remaining 46 Neighborhood Councils and any online voting related hardware/software if online elections are to be offered in Fiscal Year 2018-19 and instruct the City Clerk to work with the City Administrative Officer on transferring/reverting the remaining balance to the proper location.

- 4. Request the City Attorney to prepare the appropriate ordinances to change Neighborhood Council Elections conducted by the City Clerk to odd numbered years beginning in 2019 and include any necessary language for a one-time extension of terms (from 2018-to 2019).
- 5. Request Neighborhood Councils to amend their bylaws, if necessary, to effectuate the change of Neighborhood Council Elections from 2018 to 2019.
- 6. Instruct the City Administrative Officer to report on the funding necessary to enable EmpowerLA to begin the Neighborhood Council Election outreach process in September 2017.

- Complaints about scrolling online ballot, which was confusing to voters as to when the voting was completed and caused delays by starting over at the top if any changes were made to the selections.
- 4. Allegation that a stakeholder voted online and at the polls. No proof was provided when requested by staff, and upon review, no evidence to support the allegation.
- 5. Received compliments from Spanish speaking voters who were able to complete the online voting process entirely in language.
- 6. Community issue brought out more voters in 2014.

- Election staff released voter registration information with supporting documents to the Neighborhood Council and the candidates after complaints from candidates that the Neighborhood Council was doing no election outreach so candidates wanted to do outreach. This breach of security included the data of more than 100 voters. EmpowerLA responded quickly and enrolled all voters who opted for protection with an Identity Theft Protection Plan.
- Allegations from candidate that she was able to vote twice because she was given two
 voting credentials. Upon review, candidate was given a second voting credential because
 she registered to vote in the wrong category so that she would not be able to vote for
 herself. The initial voting credentials given to her were then cancelled.
- 3. Allegations from voters who stated that they did not receive their voting credentials or that they received them the day before the elections. Staff investigation found that those who did not receive voting credentials were missing documents still and told to go to the polling location to vote instead. Staff confirmed that voting credentials for verified voters did go out right before the elections due to late processing. Staff then worked on shortening the voting verifications turnaround to Everyone Counts to 5 calendar days.
- Polling day location was divided into two rooms, online and paper ballots, because of the
 anticipated high turnout. Only those who had started voter registration online were
 allowed to vote in the online room.
- 5. There was a mix up with two voters who had the same name, but not the same birthday. Everyone Counts staff were onsite to observe and was able to correct the error and have the one who voted with the wrong birthday come back to vote again. Staff were instructed to double check all of the fields to ensure that those with the same name had the same birthday as their identification.
- 6. This was a very contentious election with multiple challenges filed.
