Notice of Hearing for Proposed Water Rate Restructure and Increases for the Los Angeles Department of Water and Power

On Wednesday, February 17, 2016, at 10:00 AM, or as soon thereafter as the matter may be heard, the Los Angeles City Council is scheduled to hold a public hearing in the John Ferraro Council Chamber, Room 340, City Hall, 200 North Spring Street, Los Angeles, CA 90012. This will be a public hearing before the City Council to allow public testimony and discussion of the proposed restructured water rate ordinance and increases of the Los Angeles Department of Water and Power (LADWP) water rates. The City Council will take and consider written and oral comments, including all written protests against the proposed charges, as required by Article XIII D, Section 6, of the California Constitution, determine if a majority protest exists, and consider whether to approve the proposed Water Rate Ordinance. Oral protests at the public hearing will not qualify as a protest, unless accompanied by a written protest. This notice is being sent to the owner of record of each parcel in LADWP's service area and to all LADWP water service customers. If neither you nor your property receive LADWP water service, this notice does not apply to you. Written protests to the proposed rate changes may be submitted at the public hearing or delivered in person or mailed to the City Clerk, 200 North Spring Street, Room 395, Los Angeles, CA 90012, in time sufficient to be received prior to the close of the public hearing. A valid protest must include: the name of the owner or customer of record, the parcel address, and a statement of protest ("I/we protest" will suffice). Please also write "LADWP Water Rate Ordinance" on your written protest. Email protests will not be accepted. Please note each customer of record on the same account will be counted as a single vote, regardless of the number of persons listed on the application for water service. Only one written protest per parcel will be counted. If a majority protest exists, the applicable proposed rate changes will not be imposed.

Parking is available in private lots surrounding City Hall, and City Hall is accessible by public transportation. As a covered entity under Title II of the Americans with Disabilities Act, the City of Los Angeles does not discriminate on the basis of disability and, upon request, will provide reasonable accommodation to ensure equal access to its programs, services and activities.

Note: City Council meetings are broadcast live on cable television Channel 35 and on the internet at [redacted]. 

I protest the proposed water rate hike for many reasons.

First, as a longtime homeowner of a very large parcel in the Valley, many owners similar to me have never gotten any consideration of our needs. LADWP has set very dubious limits to qualify for reduced rates in terms of parcel size and climate.

As to climate, the Valley is usually ten to twenty degrees hotter than the rest of Los Angeles, yet many of us do not get rates recognizing that. Currently, LADWP has set very dubious boundaries to qualify for those rates, and erroneously suggests that properties just a few blocks from my parcel are much hotter. It has gotten up to 113 at my place on days when it was the same temperature at my workplace which is zoned for cheaper rates.

As to parcel size, mine is just under half an acre, but at 17,000 sq. ft. misses the cut-off for the large parcel rates. All properties on my street are well over 15,000 sq. ft. Although I removed all lawns here at least ten years ago, this property has many mature trees that provide shade and fruit. Surplus from the latter often goes to needy organizations. A certain amount of water is needed to keep these trees from dying. It makes no sense for the city to fund tree-planting initiatives when on the other hand, when it is penalizing owners from keeping trees from dying.

I have two huge magnolias, several carrotwoods, four each of loquat and orange trees, several tall Eugenias, fig, lemon, and kumquat trees. Recently, a palm tree here had to be removed (\$1500) because it was bone dry. LADWP isn't giving me credit for having cut back on water usage in the area where it stood.

In addition, many Valley homes have pools. It is very costly to have a pool removed, but in an emergency, such as an earthquake, they are valuable reservoirs. However, proper upkeep requires maintaining water levels. The city, of course, doesn't have any program to fund costly pool covers.

I've long had two rain barrels and other catch basins, and conserve water like a fiend. Plus, I invested many years ago in solar which also benefits LAUSD and its mandate to use certain minimums of green energy.

Customers have noted that their recent conservation efforts have only been met with an imminent rate hike. Much of LADWP's financial needs should be addressed by scrutinizing its own budget for wasteful spending, over generous pensions, and to streamline operations. Many positions exist only to perpetuate nepotism.

Other factors affecting water use in the state are caused by unchecked growth in population. A good portion of this is encouraged by short-sighted politicians who've encouraged illegal aliens to flood the state over the past thirty years, plus used more taxpayer money to support and reward them. In addition, many of these households are given preferences and discounts by utility companies for "being poor" as many benefits aren't counted as income. Enforcing current immigration laws would cut water use by vast amounts and also give a surplus to other government coffers.

Thus, I see this rate hike as not only unfair, but just another in a series of short-sighted slap-dash measures -- "dump it on the homeowners" -- and not one that is looking at the bigger picture.
