To Whom It May Concern:

We protest the proposed LADWP rate increase for a number of reasons.

First, we've done everything in our power to reduce the amount of water our property uses. We removed all the grass in our backyard and replaced it with hardscape concrete. Then we replaced the entire front yard with artificial turf and drought tolerant plants. This significantly reduced our water consumption. All of our showers and toilets are low-flow and now that the kids are grown, it's only myself and my husband using water/power at this address. We've also installed Solar Power so that our energy consumption is minimal and we do what ever we can to keep our usage of both water and power at its minimal.

We understand the need for the City to install new pipes across the Los Angeles area, but a rate increase to property owners that are using the least amount of resources and consumption really needs to be considered. Perhaps those who have not conserved and who continue to waste water should be the ones paying for additional City needs.

And, to add to this, we live in the Aliso Canyon Gas Waste land area and now have to deal with all the repercussions from this, possibly even being relocated! This added rate hike on top of all the other environmental hazards we live with are too much for taxpayers at this time.



City Clerk,

We protest the proposed water rate increases for the majority of LA. While the majority of residential users have complied with the Governor's proposed water usage reductions, along with the Mayor's Executive Directive #5, those who haven't (Beverly Hills and other affluent cities) should be charged higher rates for water usage above and beyond typical baseline rates. *Do not penalize those who have cut back by increasing their rates or lowering the level of their existing Tier levels by adding/creating new Tier levels.*

The DWP, like any other business, must properly maintain their infrastructure and protect the precious commodity that they are paid to supply. If they do not properly maintain their pipes and resulting pipe failures waste hundreds of thousands of gallons of precious water multiple times a month, they should not be entitled to passing along those costs to their customers. It would be nice if my business had no competition and was able to increase prices to ensure that I was able to stay in business, even though I wasted money, overpaid employees through unnecessary overtime and inefficient policies, including but not limited to a lack of maintenance of infrastructure. These folks must be accountable for the position they have put themselves in.

Focus on fixing the DWP before allowing them to creatively increase their pricing structures on the backs of residential customers. I am so often reminded of why I personally no longer choose to live in an area serviced by the DWP.


