**Re:** "Protest" DWP Water Rate Hike

Dear Department of Water and Power,

I strenuously protest any and all rate hikes. Rather than raise rates I would suggest DWP streamline their process, make the company more efficient and bring salaries into alignment with the rest of the World performing similar jobs. The staggering amount of revenues coming in should be way more than enough to cover daily costs, upgrades and implementation of water conservation; instead it's just being wasted by a wasteful management Team. DWP in my book stands for The Department Of Wasteful Practices... and this has got to stop. Throwing more money at a broken system is not the answer. Customers should not have to pay more simply because of DWP's inability to effectively run a business, and I fear this is just the case. Rates have been going up for years and it's time for you to cover the shortfalls, not your customers.

For years, a portion of the high rates we have all been paying were supposed to be set aside for maintenance and infrastructure improvements. Since funds have been terribly mismanaged you now want us to effectively pay for it again through a rate hike? I say NO!

DWP continues to put profits ahead of the needs of the people. Like most other giant organizations in America, the bottom line mentality of corporations has got to shift and should instead place the greater good of the people over the greedy habits of profit driven business at the expense of the very people you claim to support.

One great example is the Chatsworth Wildlife Refuge. DWP shut off the water to this valuable resource, killing wildlife and taking away a beautiful wetland. I would argue that the reason DWP turned off the water is because you do not get paid for that water, although you like to say it was to save water, I beg to differ. Had there been a paying customer and a water meter feeding that wetland, I have no doubt the water would still be flowing today.

All the while, DWP continues to allow residential customers to water their grass as much as they like because it generates revenues. Watering Grass is the single most wasteful use of water in this City. In my view, DWP clearly is more interested in generating revenue and profits then you are about the unprecedented drought we all face. If we run out of water we are going to have millions of homes in Los Angeles which are worthless, but they will still have beautiful green lawns. How does this make sense? By simply outlawing water use for grass you would save huge amounts of water.

Finally, I have sent in numerous complaints to DWP about water wasters, complete with photographs... and nothing happens, nothing changes... When I spoke with the head of the Water Conservation unit, he told me over the phone that the water crisis is not nearly as bad as the press is making it out to be and he said that "much of the information we get is erroneous". This comment, coming from the very person allegedly tasked with enforcing water conservation in our City gives me

great cause for concern. Something is very wrong with this picture and once again, I can only surmise that the reason DWP is not effectively limiting the amount of water we all use is simply because the less water we use, the less money you make. This has got to change. Do not raise the rates so you can simply waste more of our hard earned money... No. Your motivation for the Tiered structure is not to save water, let's be honest about it... it's to line your pockets. If you really want to save water, enforce penalties, big penalties for watering grass and other wasteful practices. In the meantime, you need to perform a top to bottom overhaul of your business process and learn how to manages the money you have, don't ask us to send more money so you can continue to waste it.

No! I protest any rate hike.
