# PROTEST

I live in Woodland Hills, California. I'm a single female living on a 1/3 acre parcel. I've lived in my home for 13 years.

Since water restrictions, I now:

C.F. 15-1543

- water yard twice a week (with exception of now -- since the Godzilla el Nino is upon us). My sprinklers have been turned off since mid-December. **TO SAVE MONEY ON MY LADWP BILL.**
- I flush my toilet only when necessary. This means if I have "solid" refuge, the toilet gets flushed. Otherwise, I flush every 3-4 times I go to bathroom. **TO SAVE MONEY ON MY LADWP BILL.**
- I used to "tip" my trash collectors every December. But, upon learning how much money they make -- and that they have a PENSION, I no longer tip. **TO SAVE MONEY TO PAY MY LADWP BILL.**
- when I shower, my water is cold. So everytime I shower (as well as my houseguests), I collect cold water in a large bucket (until water gets hot) -- and with the collected water, I water my outdoor plants. **TO SAVE MONEY ON MY LADWP BILL.**
- and speaking of showers, once water is warm...my body gets wet. I turn off shower. Soap my body. Turn water back on and remove soap. **I DO THIS TO SAVE MONEY ON MY LADWP BILL.** My shower is typically no longer than 2 minutes.
- I have a hose attached to my washing machine and the excess water gets sent to my backyard. **TO SAVE MONEY ON MY LADWP BILL.**
- When I wash dishes, again I use that bucket to collect any water which would go down the sink. **TO SAVE MONEY ON MY LADWP BILL.**

I could literally go on and on. But here's the bottom line. The city and LADWP need people like myself to pay taxes and my ENORMOUS LADWP bill. People like myself (and many of my neighbors) are considering leaving not only LA County -- but the State of California. These increasing costs are driving tax-paying; LADWP-paying people away. **WHAT WILL HAPPEN WHEN PEOPLE LIKE MYSELF LEAVE LA COUNTY AND ARE REPLACED WITH PEOPLE WHO ACTUALLY CANNOT AFFORD TO PAY LADWP PRICES?**

With all the above changes I've made, I STILL barely can afford my LADWP bill. So yes, please do continue to increase our rates -- and then you'll continue to see mass exodus out of LA County and the State of California.

**My recommendation would be to:**

- utilize LADWP \$40 million slush fund
- immediately stop Pension
- look to Private industry and how successful Private industry has been in running a business.
- Immediately, look at salaries of ALL LADWP employees and ask if those salaries are warranted....
