



1. I am 76 years old and live alone and retired.
2. I water my grass 3 times a week for 8 minutes each spigget
3. My bill is outrageous, it is \$600-700 every 2 months.
4. There is no reason that I should have to pay this amount of money especially when employees of the Department of Water & Power have always had exceptional salaries both working and retired.
5. I pay for Medicare each month and I have been paying for Medicare every since it went into effect. Employees of DWP do not pay for Medicare, and have exceptional salaries. 


